Subject: FIR regarding brutal hit and run caused by extreme rash and criminally negligent driving of scooter bearing registration no. WB-74-AQ-3035 resulting in grievous multiple fractures on left leg, bruises over face and head of my mother Phuwkit Lepcha.

Sir/Madam,

I, Dorjee Palden Jamang, son of Palden Jamang resident of Lower Tadong, Gangtok, Sikkim would like to lodge this FIR against the lady rider/driver of a scooter bearing registration no. WB-74-AQ-3035, who committed a heinous offence of Hit and Run by driving in an extremely rash, reckless, dangerous and criminally negligent manner injuring my mother grievously.

That today somewhere between 1:30 Pm to 2: Pm date 10/12/2025 at Salugara, near Cosmos view Apartment, while my mother Smt. Phuwkit Lepcha was walking on the side of road with my son Marten Jigme Nangyal Jamang, the lady accused scooter rider, driving a Scooty bearing registration no. WB-74-AQ-3035, came at a very high speed in an uncontrollable manner endangering human life and with complete disregard for public safety, the said lady rider violently rammed into my mother with great force from behind, hurling her several feet onto the road. The impact was so severe that my mother screamed in pain and collapsed, while the accused instead

of stopping or helping, deliberately sped away from the spot to destroy evidence and evade law, thereby committing a cold blooded act of Hit and Run.

This criminal act clearly demonstrates the reckless, inhuman and heartless conduct of the accused.

Due to the brutal impact/road accident caused by the aforementioned scooter my mother Smt. Phurkit Lepcha has suffered grievous injuries with two fractures (broken bones) in her left leg, bruises on her left cheek and left hand. She is in extreme pain and trauma and is presently admitted at Neotia Hospital, Siliguri, West Bengal and the doctors have advised surgery to fix the broken legs. My son Master Jigme Nangyal Tamang too has suffered minor injury with bruise over left ankle (hand) because of the said accident.

In view of the above, I most respectfully and urgently request you to:

- i) register this FIR.
- ii) trace, seize and confiscate the offending scooter forthwith.
- iii) arrest the accused rider immediately.
- iv) collect CCTV footage from the surrounding area.
- v) Take the strictest possible legal action against the accused.
