SUB :- F.I.R. AGAINST SEVERE DOWRY HARASSMENT (SECTION 498A, 406, 323, 506 IPC & DOWRY PROHIBITION ACT) AND MARRYING ME (ANITA MAHATO) BY SUPPRESSING PREVIOUS MARRIAGE

Dear Sir,

Most humbly and respectfully I, Smt. Anita Mahato, w/o. Shree Bijay Mahato, Housewife by Occupation, Indian by Nationality, Hindu by religion, resident of Pabitra Nagar, Champasari, Kalkut (P), P.O. Champasari, P.S. Pradhannagar, Dist. Darjeeling- 734003, West Bengal, would like to draw your attention towards the following facts :-

(1). That I am living my hellish married life with Shree Bijay Mahato since about 18/19 years.

(2). That we are 2 members family having husband and wife.

(3). That just after a year of marriage my husband started torturing me without any reason. And during that period when I was get pregnant my this so called husband has started quarreling with me and tried to compel me for abortion and when I denied he assaulted me so brutally that my initial/first year of pregnancy was miscarried and as a result of which I could never conceive any more. And after 18/19 years of marriage I'm still alone without any

baby. This is only because of inhuman, brutal, extreme savagery, predatory instinct, animalistic behavior, evil, rascal, cruel, hellistic characters of my husband.

(4). That now in recent years my said husband was torturing me randomly with different excuses and not only torturing he was abusing and assaulting me regularly. I was Mum because of social prestige.

(5). That it is pertinent to mention here that since marriage my said husband regularly demanded liquid/cash money from my family through me on different occasions and context. His demands were fulfilled also by my parents and family members. I have given him sometime 1 lakh, sometimes 2 lakhs, sometimes 1.5 lakhs, sometimes 50 thousands.....and it was repeated also. These were all given for avoiding assault, torture, misbehave on me.

(6). That I have some immovable properties in my name owned from my paternal side. And when my said husband came to know regarding the said properties he has started torturing me with double intensity for transferring the title ownership of those immovable properties from myself to his name/favour.

(7). That when I came to know about my husband's first/previous marriage at Bihar I have started quarreling with my husband that why he has spoiled her life by SUPPRESSING and hiding his PREVIOUS marriage ?

By hearing this he became furious and started abusing and scolding me and threatening me by saying, " साली हरामजादी तुझे इससे क्या मतलब है, चुपचाप तू सारे जमीन जायदाद मेरे नाम पर कर वरना तुझे जिन्दा नहीं छोड़ूंगा । मेरा साला (गौरी महतो) और बेटा (अरबिन्द महतो) हम तीनों मिलके तुम्हें खत्म करेगें । जा तुझे जो उखाड़ना है उखाड़ ले मुझे कोई फर्क नहीं पड़ता है ।"

(8). That just yesterday only my said husband, on different excuses, has started quarreling with me and all of a sudden there appeared his brother in law(साला), Gouri Mahato and his son Arvind Mahato and they all three have started snatching my hairs, scolding, assaulting and pulled me out of my house and severely injured me.

(9). That I have enclosed herewith the xeroxed copy Medical Certificate.

Under the above facts and circumstances I humbly request you to look into the matter very seriously do the needful against these three anti-social elements, namely, (1). Vijay Mahato, (2). Gouri Mahato and (3). Arvind Mahato, and take proper legal actions against them.
