Sir,

In producing herewith 04 (four) following accused persons namely (i) Ashim Sarkar (32Yrs) S/O Lt. Autul Sarkar of Samar Nagar, near Soni Mandir, PS Pradhannagar, Darjeeling, (ii) Rohit Mahato (21yrs) S/O Lt. Prakash Mahato of Ratanlal Busty, ward No 45, PS- Pradhan Nagar, Dist. Darjeeling (iii) Arbin Pradhan (30yrs) S/O Gobin Pradhan of Salbari Bazar, old petrol pump, PS- Pradhan Nagar, Dist.- Darjeeling and (iv) Raju Kumar (20yrs) S/O Lalu Sahani of Naya Bazar South Palas, PS- Pradhan Nagar, Dist. Darjeeling, under arrest along with the following seizure articles viz :- (i) One iron made sharp cutting weapon locally called as "Hasua" measuring approx 25 inches in length including its wooden butt (ii) One sharp cutting iron made weapon locally called as "Chopper" measuring approx 17 inches in length including its wooden butt (iii) one iron made Haksaw blade measuring approx 24 inches in length including its wooden butt, (iv) one house breaking instrument locally called as "Sabol" measuring approx 24 inches in length (v) one iron made hammer including its wooden butt measuring approx 8 inches in length (vi) one Plus measuring approx 7 inches and (vii) one multi colour nylon bag. I, ASI Bikash Roy of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above named four (04) arrested accused persons and others 04/05 unknown miscreants who involve in this crime, to the effect that on 11.12.25 at 23.25 hrs I received a specific source information that about 08/09 miscreants equipped with deadly weapons assembled at one abandoned house situated at Himachal Colony under PS- Pradhan Nagar, Dist. Darjeeling and they were making preparation for committing Dacoity at Himachal Colony and its surrounding area. Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 658 dated 11.12.2025 and informed the matter to you. As per your kind order and direction, I along with, ASI Biplab Kr Das, ASI Prabal Sarkar and force all of Pradhan Nagar PS, SPC left for Himachal Colony under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed night RT van officer ASI Sanjay Roy and requested him to come to Himachal Colony to accompany us. At around 23.45 hrs we arrived at Himachal Colony under PS- Pradhan Nagar, Dist. Darjeeling and after a while night RT van officer ASI Sanjay Roy and force arrived at the spot to accompany us. I shared the information with my raid team and briefed them properly. Then, I contacted my source and from a considerable distance he pointed the place where the miscreants were assembled. Then, I requested two available independent witnesses namely (i) Raja Sahani (26yrs) S/O Chunchun Sahani of Rajendranagar, Cooliepara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Arun Sahani (26yrs) S/O Upendra Sahani of Rajendranagar, Cooliepara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance we noticed that 08/09 persons were assembled in a one abandoned house at Himachal Colony Under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching towards them, they tried to flee away from the spot but on hot chase we managed to apprehended above named four (04) accused persons while 04/05 others unknown miscreants managed to flee away taking the advantage of darkness. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which they kept concealed inside one multi color nylon bag.
