Subject: Complaint Regarding Brutal Assault, Stone Pelting, and Threats to Life.

Respected Sir / Madam,

I Ritesh Jaiswal, Son of Ramesh Prasad Jaiswal, residing at Gowala Patty, Gully No. 03, Ward No. 04 of S.M.C., Siliguri, P.O. Siliguri Bazar, P.S. Khaipara Town Out Post, District Darjeeling, West Bengal - 734005, hereby lodge this complaint regarding a serious and unprovoked attack upon me. Yesterday night around 10:30P.M. at Gowala Patty, Gully No. 01, Near RCM Shop, while I was returning towards my home, a group of individuals namely Zahir Khan and his two other friends, suddenly surrounded me on the road and violently assaulted me. They mercilessly beat me with fists, kicks, Slaps and other objects like brick, wooden battam and etc in my head and also began throwing stones at me with the clear intention of causing grave injuries. The attack was sudden, organised and carried out in a manner that made it impossible for me to defend myself. As a result of the severe beating and stone pelting, I sustained multiple injuries and fell to the ground in a helpless condition. During the incident, the accused persons also set a dog on me, causing further panic and fear, and additionally attempted to snatch my scooty, trying to forcibly take it away from my possession, during the attack I somehow tried to escape myself and ran away from the spot, immediately I went to Siliguri District Hospital in a injured situation for medical Aid, where I had been admitted the entire night due to the seriousness of the injuries and trauma. I have been discharged today afternoon at around 11:30 A.M. after receiving medical treatment, and the hospital documents are enclosed for your reference.

During this entire assault, the attackers repeatedly issued direct and clear threats, warning me that if I approached the police or attempted to file any complaint, they would again attack me in the future and also harm my family members as previously also the person named Zahir Khan had threatened me at multiple occasions. These threats have created extreme fear and insecurity for my life and safety as well as for the safety of my family members. The nature of the attack, the coordinated manner in which it was carried out, the use of stones, and the repeated threats clearly show that the above named persons acted with a deliberate and malicious intention to cause serious harm and suppress my lawful rights. Such acts cannot be ignored as they pose a continued danger to me and my family.


In view of the above, I most respectfully request you to register an FIR, conduct an immediate and impartial investigation, identify and take strict legal action against all persons involved, and provide necessary protection to me and my family. I am enclosing the hospital papers for your immediate consideration.
