Sir,

With due respect, I ASI Pramod Tamang of Ashighar OP under Bhaktinagar PS , SPC do hereby lodge a written complaint against the following persons namely 1) Deep Mandal, S/O-Maru Mandal (2) Wife of Rajat Dhopa (3) Sister of Bhajan Sarkar (4) Namita Sarkar, W/O-Sujan Sarkar of Bagrakote, PS-Siliguri, Dist-Darjeeling (5) Sushmita Sarkar (6) Sangita Sarkar (7) Niyasa Mandal, S/O-Amar Chand Mandal (8) Mother of deceased Jharna Sarkar Das (9) Miss Sumi Mandal, D/O-Santosh Mandal (10) Mother of Bhajan Sarkar (11) Chandana Majumder (12) Pushpa Barman, W/O- Rahul Barman (13) Rikh Biswas, S/O-Sanu Biswas (14) Supriya Sarkar (Niece of Bhajan Sarkar) (15) Mother of Arijit (16) Samiran Bhattacharya (17) Pampa Bhattacharya, W/O- Samiran Bhattacharya (18) Gudiya, D/O-Bimal Biswas (19) Gouri Roy, W/O-Bhanu Roy (20) Jolly, H/O-Mana (School Teacher) (21) Raju Mandal, (22) Rudra Mandal (23) Sujata Mandal (24) Kapil Deb (25) Sayan Basak (26) Sayanita Mandal (27) Rahul Deb (28) Samaya Saha (29) Jyoti Biswas and others of Uttar Shantinagar under Ashighar OP as well as from other area for disobeying of the Govt. order, creating obstruction and assaults on Police personnel while the police officers were performing their govt. duty and damaging private property.

The facts of the case in brief is that today on 11/12/2025 while I, along with C/376 Shyamal Chowdhury and CV/307-Fulkumar Barman, were performing morning patrol Van duty under Ashighar OP, vide Ashighar OP GDE No. 310 dated 11/12/25 and MCC No. 2167/25 dated 11/12/25, at around 12:05 hrs, I received information from the duty officer about a chaotic situation in Uttar Shantinagar under Ashighar OP related to a female individual who had committed suicide. We promptly proceeded to Uttar Shantinagar to verify the situation and arrived at approximately 12:20 hrs. Initially, the area appeared peaceful. Through preliminary inquiry, we learned that on 9th December 2025, a woman named Jharna Sarkar Das, wife of Bhajan Sarkar, had poisoned herself and was receiving treatment. Tragically on the morning of 11th December, she was declared dead. It was alleged that her suicide stemmed from an alleged affair between her husband, Bhajan Sarkar, and their neighbour, Mampi Sarkar, wife of Animesh Sarkar. Given the potential for unrest, I informed the Officer-in-Charge of Ashighar OP and requested backup forces to prevent any law and order situation.

Following the O/C's guidance, we stationed ourselves near Mampi Sarkar's house to avoid any untoward incidents. Shortly afterwards, we observed that the aforementioned individuals, along with a large crowd, began approaching Mampi Sarkar's residence with bricks, stones, and sticks. They attacked the house, pelting stones and attempting to force their way inside. Despite our repeated requests for calm and restraint, the crowd became aggressive and disregarded our pleas. As time progressed, more individuals joined the crowd, intensifying the situation. We repeatedly attempted to de-escalate the tensions, but our efforts were met with aggression. Members of the crowd abused us, assaulted us, restrained us from discharging our duty, and tried to damage government vehicles with bricks, resulting in injuries to our team. Ultimately, seizing the opportunity presented by our limited numbers, the aggressors forcibly invaded the house, vandalizing the premises and its contents while we stood by. The family members of Mampi Sarkar managed to lock themselves in a room to protect themselves.

Following the arrival of additional officers and superior officers, we worked diligently to regain control of the situation. Eventually, we successfully escorted Mampi Sarkar and her family to Bhaktinagar Police Station for their safety. There is every possibility of a law and order situation, breach of peace is still going on in the area and the alleged persons may cause any untoward incident in near future over the said issue. Strict vigil is being maintained to avoid any incident.

Under the above facts and circumstances, I request you that a specific case against the aforementioned persons may kindly started with suitable sections of law and arranged for its investigation.
