Sir,

In producing herewith one arrested accused person namely Uttam Dutta-41yrs s/o Anil Dutta of Sastrinagar, Swami Vivekananda road, ward no-41, PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:-

- i) 08 (Eight) pieces of LPG empty Gas cylinder Indane (LPG)
- ii) 11 (eleven) pieces of empty LPG (Small) Gas cylinder and One piece loaded small Gas cylinder
- iii) 02 (two) pcs of gas refilling Nozzle
- iv) One iron made ranch
- v) One big size computer weight machine
- vi) One small digital weight mechine

I SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodge written complaint against the above noted accused person to the effect that today i.e. on 12.12.25 at 00.05 hours when myself along with officers and forces of Bhaktinagar PS working out an information vide Bhaktinagar PS GDE no-566 Dt. 12.12.25 at Iskcon road, then an information received from reliable source that a huge numbers of stolen domestic gas cylinders are dumped in the shop of one Uttam Dutta style as Laxmi verity stores at Iskcon mandir road, Haiderpara under Bhaktinagar PS.

Accordingly the information communicated the same to I/C of PS. As per direction I along with the team SI Yuel Lepcha, ASI Dipak Karmakar, ASI Khagen Barman and const/374 Debraj Biswas all of Bhaktinagar PS had been to the place to work out the information vide Bhaktinagar PS GDE no- 568 dated 12.12.25 and two local witnesses were requested to presence at the time of search and seizure namely 1) Md Hasmat s/o Kalimulla of Asrafnagar ward no-40 PS Bhaktinagar Dist Jalpaiguri and (2) Amit Biswas s/o Ankush Biswas of Vidya chakro colony, ward no-44, PS Bhaktinagar Dist Jalpaiguri entered in the shop of the above noted person and during search the above gas cylinders along with re-filling nozzles having above description were recovered .It also found that the re-filling process was continue. On interrogation the above noted accused disclosed his name and identity as stated above and on demand he failed to produce any document/license in support of possession of huge number of Gas cylinders and also made incoherent statement. So, all the gas cylinders along with nozzles were seized under proper seizure list.

Under the above circumstances it is evident that the accused person above named committed theft in respect of LPG cylinders and was transporting the same to somewhere else for disposal of stolen property after refilling the same from big cylinder to small cylinder. I tried to serve notice u/s 35(3) BNSS but he refused to

accept the notice. I arrested him u/s 35 (3) of BNSS after explaining him about ground of arrest issuing proper memo of arrest and taken into custody. Whole process of search and seizure duly audio & VDO graphed. Seizure was made in between 00.20hrs to 00.40 hrs.

Hence, I request you to kindly start a specific case against the arrested accused namely Uttam Dutta-41yrs s/o Anil Dutta of Sastrinagar, Swami Vivekananda road, ward no-41, PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
