stabbing my nephew with kitchen knife.

Sir,  
This is to inform you that I Rajkumar Srivastav, s/o Lt. Shankar  
Srivastav, resident of Kalkoot, Near Teak bagan, Debidanga, P.S. Pradhan  
Nagar, Dist- Darjeeling beg to state you that my nephew namely  
Manoj Srivastav @ Bura, aged 21 years, s/o Kate Kamal Singh, resident  
with me at the above mentioned address. That from past 3 years my  
above said nephew had a ~~well~~ love relation with one Prathima Gurung,  
w/o Lt. Rajesh Kumar of Middle Pabsh, Debidanga, P.S. Pradhan Nagar,  
Dist- Darjeeling. That he used to visit her residence everyday ~~fore~~  
That today at around 08.00 am in the morning my above said nephew  
went to the residence of the said Prathima Gurung and after that  
they went into a quarrel and when the situation escalated the said  
Prathima Gurung stabbed my above said nephew with kitchen knife  
in multiple areas of his body (stomach, abdomen etc) which caused  
him grievous injury and severe blood loss. After receiving such  
information I along with my mother went to the above said  
Prathima Gurung <sup>residence</sup> and immediately took my nephew at North Bengal  
Medical College and Hospital where I admitted him and came to know  
that he received multiple stabbing injuries and now he is in a critical  
condition, fighting for his life.

So I am writing you this written complaint to take  
appropriate legal action against the said Prathima Gurung for  
stabbing my nephew and trying to kill him. For which I shall may  
remain forever obliged.
