Sir,

In producing herewith the accused person named Md Firoj (27 yrs) S/O Md Ainul of 8 th Mile, PS+Dist. Kalimpong under arrest and the following seized articles under a proper seizure list viz :- (i) one white colour carry bag containing 14 (fourteen) bottles of "COSMOS FIFTY" Deluxe Whisky each bottle containing 750 ml, i.e, total (14 x 750 ml) = 10.5 ltrs- Marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1". I SI Goutam Mallik of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complainant against the above mentioned accused person namely Md Firoj (27 yrs) S/O Md Ainul of 8 th Mile, PS+Dist. Kalimpong to the effect that today (12.12.25) at 18.15 hrs I received specific secret information that one person carrying and possessing huge quantity of illicit liquor in a white colour bag was standing at Coolipra road, Siliguri Junction near Shiv Mandir and he is selling the same in open place without any valid licence. Accordingly, I diarised the fact in the PS General Diary vide Pradhan Nagar PS GDE No. 704 dated 12.12.2025, and informed you regarding the information.


As per your kind order and direction, I, along with SI Rajiv Subba, ASI Bikash Roy, ASI Prabal Sarkar and force all of Pradhan Nagar PS proceeded to Coolipara Road, Siliguri Junction near Shiv Mandir by Government vehicle with the investigation kit. I briefed all personnel regarding the information and briefed them properly. Ater arriveal at Coolipara Road, Siliguri Junction near Shiv Mandir, I contacted with my source, and being identified by him, I noticed that one person with a white colour carry bag in his possession is standing there. Accordingly, we cordoned the place from every corner and managed to detain him. On being asked he disclosed his identity as stated above. On further interrogation he admitted his guilt and disclosed that he is possessing illegal liquor in his bag. On search the above mention liquor was recovered from his possession. On demand, he failed to produce any valid documents/licence for possessing/carrying/selling such liquor. Upon further interrogation, he disclosed that he illegally procured the liquor from Siliguri Junction area and selling the same to his designed customers for his wrongfull gain. He also admitted that he has been involved in such activities for a few days for his wrongfull gain. Accordingly, I seized the above mentioned articles from his possession under proper seizure list in presence of local witnesses. The entire process of search and seizure was made in between 20:05 hrs to 20.40 hrs, under the coverage of videography as per norms of BNSS. Subsequently, I arrested the said detained person namely Md Firoj (27 yrs) S/O Md Ainul of 8 th Mile, PS+Dist. Kalimpong after observing all the legal formalities and informed him regarding grounds of his arrest for violating the provisions of the West Bengal Excise Act.

Under the above noted fact and circumstances I pray before you that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Md Firoj (27 yrs) S/O Md Ainul of 8 th Mile, PS+Dist. Kalimpong for violating the provisions of W.B. Excise Act and may arrange to cause its investigation.


