


Sir,
In producing herewith one accused person namely- Bablu Sarkar (34 yrs/male) S/O Late Ratan Sarkar of Sarbohara Colony, Ward No. 28, PS- Siliguri Dist- Darjeeling along with the following seized articles as per proper seizure list:

1. 12 (Twelve) sealed Bottles of" Himalayan Tuk Tuk "country spirit 80 UP each bottle containing 600 ml each , amounting of Rs.60/- each,

I, ASI Rabin Lama of Siliguri PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 12.12.25 at 19.45 hrs received a source information that one person namely Bablu Sarkar (34 yrs/male) S/O Late Ratan Sarkar of Sarbohara Colony, Ward No. 28, PS- Siliguri Dist- Darjeeling is selling liquor illegally in an abandon place situated in an Institute colony. Ambedkar Bazar ward no- 28 under Siliguri PS for his wrongful gain. This refers to Siliguri PS GDE no- 581 dated 12.12.25. I informed to I/C Siliguri PS about the above mentioned information. As per order of I/C Siliguri PS, I along with ASI Minhaj Al Kader and C/160 Soumen Sarkar proceeded to Institute colony, Ambedkar Bazar ward no- 28 under Siliguri PS to work out the information vide Siliguri PS GDE No. 582 dated 12.12.25. At 19.55 hrs we reached at the spot, being identified by the source our police party found that the above noted mentioned person was busy to sell liquor to his design customer. On seeing the police party all consumed person managed to flew away but we managed to apprehend the above noted person. On being asked he disclosed his identity as noted above. On searched the above noted seized articles has been recovered. On asking he failed to produce any license or documents in respect of above noted seized articles. On further interrogation he became nervous and admitted his guilt before us and stated that he sold the same to his design customers since long for her wrongful gain. accordingly I seized the same from the exclusive and conscious possession of accused Bablu Mandal in presence of witnesses I. Amit Ghosh (35 yrs) S/O Subhash Ghosh of Tikiapara back side of Arabinda Bidyamandir, Ward No.28, PS- Siliguri, Dist- Darjeeling , 2. Krishna Sarkar (25 yrs) S/O Lakhon Sarkar of Mahabisthan Sarbohara Colony, Ward No.28, PS- Siliguri, Dist- Darjeeling after preparing proper seizure list and label and took signature of the accused person as well as witnesses duly signed by them. The seizure was made between 20.25 hrs to 20.55 hrs. I arrested the said person u/s 35(1) of BNSS after issuing a Memo of arrest appraising the ground of arrest in presence of witnesses as he violated the norms of Bengal Excise Act. The whole seizure process was recorded under Audio and Videography.

I therefore request you a specific case may kindly be started against the accused person namely Bablu Sarkar (34 yrs/male) S/O Late Ratan Sarkar of Sarbohara Colony, Ward No. 28, PS- Siliguri Dist- Darjeeling under proper section of law.
