Sir,

In producing herewith one accused person namely Binay Roy (M/41) S/O- Lt Belacharan of Uttar Ektiyashal, Khai Khai Bazar, PO-Sevok Road ,P.S- Bhaktinagar, Dist- Jalpaiguri along with the following seized articles :-

1. 20(Twenty) bottles of 70 UP OYE OYE India made liquor each bottle containing 300 ml. having MRP of Rs. 40/ branded by GALAXY CS Bottling Plant Nagrakata, Jalpaiguri marked as Exhibit-A" out of which 01(one) bottle taken as sample for examination and marked as Exhibit A-1. (Total- 6 LTR)

I, ASI Madhusudan Barman of Ashighar OP under Bhaktinagar P.S. under Siliguri Police Commissionerate do here by lodged a written complaint against above noted accused person namely Binay Roy (M/41) S/O- Lt Belacharan of Uttar Ektiyashal, Khai Khai Bazar, PO-Sevok Road ,P.S- Bhaktinagar, Dist- Jalpaiguri to the effect that today on 12/12/25 while myself along with SI Agen Lepcha, C/970-Bikash Roy, CV/603-Arun Roy were performing simultaneous drive as per order of my superior vide Ashighar OP GDE NO-356 dated 12/12/25, at about 17.10 hrs received a specific input from the source that huge quantity of illicit liquor is stored at the shop of the above noted accused person at Dudh More, Near Baneswar More under Ashighar OP and has been selling to his designated customer for his wrongful gain. Accordingly the fact was informed to O/C Ashighar OP and as per his direction at about 17.15 hrs I along with above noted officer and force left for Dudh More, Near Baneswar More under Ashighar OP to verify the veracity of the information. At about 17.40 hrs we arrived at Dudh More, Near Baneswar More and waited there. After a while on being identified by the source we held a raid at the shop of the above noted accused person and managed to apprehend him. On asked the apprehended person disclosed his name and identity as noted above and stated the fact that he is the owner of the said shop. Thereafter, we started searching the shop. On search we found and recovered 20 (Twenty) bottles of 70 UP OYE OYE india made liquor each bottle containing 300 ml. having MRP of Rs. 40/ branded by GALAXY CS Bottling Plant Nagrakata, Jalpaiguri (Total- 6 LTR) from the said shop. On interrogation the apprehended person could not produce any valid documents in respect of the said illicit liquor. He also stated that he has been doing this liquor business since long for his wrongful gain and confessed his guilt. Accordingly, I seized the same in presence of witnesses as per proper seizer list duly signed by the witnesses. As per provision the entire process of search, seizure was done by audio video electronic means through E-Shaksya portal . As he violated the rules and norms of Bengal Excise Act, as such I arrested him after observing all the formalities issuing proper memo of arrest in presence of witness and the communication of ground of arrest has duly been served to him in writing. The search, seizure and arrest was made in between 17.56 hrs to 18.05 hrs on 12/12/25.
