With due respect, I am producing herewith the 03 (three) arrested accused persons namely 1] Manish Tamang (30 yrs approx), S/O- Lt. Madan Tamang of Ghum Sukhia Road, Block 3, PS- Jorbunglow, Dist- Darjeeling, (A/P- Salbari Bazar, PS- Pradhannagar, Dist- Darjeeling) (not verified) 2] Swapan Sutradhar (37 yrs approx), S/O- Lt. Badal Sutradhar of Salbari Bazar, PO- Salbari, PS- Pradhannagar, Dist- Darjeeling (not verified), 3] Sakil Shake (20 yrs approx), S/O- Maidul Shake of Mallaguri Jhopar patti, PO+PS- Pradhannagar, Dist- Darjeeling (not verified) and the following articles under seizure :-

1. One torch light from the possession of accused named Manish Tamang.
2. One plus from the possession of accused named Swapan Sutradhar.
3. One iron made Hammer from the possession of accused named Sakil Shake.

1, PSI Avijit Banik of Matigara PS, Siliguri Police Commissionerate beg to state that on 04.12.2025 at 23:50 hrs, I received a secret source information that a gang of miscreants were assembled in a open place at Chandmuni T.E beside Shiv Temple under PS- Matigara, Dist- Darjeeling with deadly weapons and making preparation for committing dacoity at Uttarayon under Matigara PS. Accordingly, I informed the fact to you and diarized the matter vide Matigara PS GDE No- 221, Dated- 04.12.2025. As per kind order myself along with C/219 Sanatan Chitrakar, C/868 Sujal Roy both are of Matigara PS, Siliguri Police Commissionerate left for Chandmuni T.E beside Shiv Temple under PS- Matigara, Dist- Darjeeling to work out the information in hand. At about 00:05 hrs on 05.12.2025 we arrived at Chandmuni T.E beside Shiv Temple under Matigara PS. After arrival of the spot and as identified by the source we found that 10/11 persons were assembled at a open place beside Shiv Temple at Chandmuni T.E, PS- Matigara, Dist- Darjeeling and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended three (03) persons of them. On interrogation the apprehended accused persons, they disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there to commit dacoity at Uttarayon under Matigara PS area. They also stated that others 07/08 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 03 (three) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 00:10 hrs to 00:28 hrs on 05.12.2025. The whole process of seizure was made under videography and the video was made through E- Shakshya app.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely 1] Manish Tamang (30 yrs approx), S/O- Lt. Madan Tamang of Ghum Sukhia Road, Block 3, PS- Jorbunglow, Dist- Darjeeling, (A/P- Salbari Bazar, PS- Pradhannagar, Dist- Darjeeling) (not verified) 2] Swapan Sutradhar (37 yrs approx), S/O- Lt. Badal Sutradhar of Salbari Bazar, PO- Salbari, PS- Pradhannagar, Dist- Darjeeling (not verified), 3] Sakil Shake (20 yrs approx), S/O- Maidul Shake of Mallaguri Jhopar patti, PO+PS- Pradhannagar, Dist- Darjeeling (not verified) and others and arrange for its investigation.
