Sir,

With due respect, I am producing herewith the following article under seizure.

1. One TATA truck bearing registration No.- WB 78/ 0058 loaded with river bed materials.

I, ASI Chandra Prakash Adhikari, presently attached with Matigara PS under your kind control, beg to state that on 11.12.2025 at 02.30 hrs, left PS for special night mobile van duty with C/219 Sanatan Chitrakar and C/868 Sujal Roy vide Matigara PS GDE No. 563, Dated- 11.12.25 against illegal transportation of river bed materials under Matigara PS area. At about 06.30 hrs, received source information that one truck having Registration No. WB 78/ 0058 is loading river bed materials from Balason river illegally at Pappu Ghat. After getting the information, I moved towards Pappu Ghat for detain the said vehicle. On the way, at about 07.00 hrs at Rabindra Nagar near Matri Chaya under Matigara PS, I saw the above noted truck was coming from Pappu Ghat side. Seeing the Police van, the driver of the said vehicle ran away left the vehicle on the road at Rabindra Nagar. I searched for the driver of the said vehicle but in vain. Accordingly, I inform the matter to I/C, Matigara PS and as per his direction, in presence of local witnesses, I seized the vehicle having Registration No. WB 78/ 0058 in abandon condition which was loaded with river bed materials. I cannot check the papers of the said vehicle as well as river bed materials as the driver was absconded. The whole process of search, seizure was made in between 07.05 hrs to 07.15 hrs under proper videography as per Law.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the involved unknown accused persons and kindly arrange for its investigation.
