Sir,

With due respect, I am producing herewith 01 (One) arrested accused person namely **Chiranjit Das (23 yrs approx), S/o- Ajay Das of Parimal Nagar, PO+PS- Matigara, Dist - Darjeeling** and the following articles under seizure :-

1. One TATA truck bearing displayed No- WB-23/1107 loaded with river bed materials(Sand).

I, ASI Bikash Roy, presently attached with Matigara PS under your kind control, beg to state that on 12.12.2025, during my night mobile van duty, vide Matigara PS GDE No. 613, Dated-12.12.2025, when myself along with force namely C/219 Sanatan Chitrakar, C/523 Sanjit Kundu all are of Matigara PS, SPC were at Binoy Krishna Pally, Patiram Jote, PO+PS- Matigara, Dist- Darjeeling, at about 04.15 hrs on 12.12.2025, found that one TATA truck bearing displayed No- WB-23/1017 was coming from Parimal nagar ghat. Accordingly, I stopped the vehicle and found the vehicle was loaded by the river bed materials (Sand) in the carrier of the truck. On demand the driver could not produce any valid or relevant documents in support of said vehicles and he also failed to produce the valid documents relating to the loaded sands. On further grilling he also stated that he procured the sand fraudulently somewhere from Parimal nagar ghat and taking the same for disposal somewhere for his wrongful gain. Accordingly, I informed to the matter I/C, Matgara PS over telephone and as per his direction, I seized the above noted loaded vehicle by preparing proper seizure list in presence of independent witnesses, the whole process of search and seizure was made in between 04:25 hrs to 04:33 hrs by WB E- Sakshya application as per law, after that I arrested the accused driver namely Chiranjit Das (23 yrs approx), S/o- Ajay Das of Parimal Nagar, PO+PS- Matigara, Dist - Darjeeling by preparing proper memo of arrest and informed him ground of arrest.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused person named Chiranjit Das (23 yrs approx), S/o- Ajay Das and the owner of the seized vehicle kindly arrange for its investigation.
