Sir,

With due respect, I am producing herewith 01 (one) arrested accused person named Gajender Thakur (40 yrs), S/O- Kalpanath Thakur of New Chumta Tea Garden, Thakur Tolly, PO- New Chumta, PS- Matigara, Dist- Darjeeling and 08 (Eight) bottles of Cosmos Fifty 50 up deluxe whisky each bottle containing 750 ml and in total 6 Liters seized articles. The ground of arrest duly been communicated with him.

I, ASI Dipak Kumar Chhetri, of Matigara PS, SPC under your kind control beg to state that on 12.12.2025 during special evening patrolling van duty, I received a secret source information that one person as noted above is selling liquor illegally from his house located at New Chumta Tea Garden, Thakur Tolly, PO- New Chumta, PS- Matigara, Dist- Darjeeling. Accordingly, myself along with C/523 Sanjit Kundu, and C/219 Sanatan Chitrakar all are of Matigara PS, SPC left for New Chumta Tea Garden, Thakur Tolly under Matigara PS to work out the information in hand. At 18.15 hrs we arrived at New Chumta Tea Garden, Thakur Tolly in the house of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling liquor from his house. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he is selling liquor from his house located at New Chumta Tea Garden, Thakur Tolly, PS- Matigara, Dist- Darjeeling for his wrongful gain. On being search his house, the above noted liquor were recovered. On demand he failed to produce any valid documents/license in respect of store/sale of the liquor which were recovered from his house. Accordingly, I seized the above noted liquor which were found from his possession under proper seizure list and arrested him under proper memo of arrest and informed him ground of his arrest and observing all the formalities of search, seizure and arrest. The whole process of search, seizure, label & arrest was made in between 18.25 hrs to 18.45 hrs on 12.12.2025 by WB E- Sakshya application as per law.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Gajender Thakur (40 yrs), S/O- Kalpanath Thakur of New Chumta Tea Garden, Thakur Tolly, PO- New Chumta, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
