With due respect, I am producing herewith 01 (one) arrested accused person ~~accused person~~ Tengey Tamang (24 yrs approx), S/O- Lt. Phurba Temba Tamang of Sonada Ratomatey, PO-Sonada, PS- Jorbunglow, Dist- Darjeeling (not verified) under arrest. The ground of arrest duly been communicated with them and the following articles under seizure :-

- (i) One (01) Improvised small fire arms having wooden butt measuring 08 (eight) inch approx in length from barrel to butt with one trigger, striking hammer, striking pin and one magazine in working condition and Marked as "Exhibit-"A".
- (ii) Two (02) round of live ammunition inscribed "KF" "7.65" on its base and marked as Exhibit-"B".

I, ASI Dipak Kr. Chhetri of Matigara PS, SPC do hereby lodge this written complaint against the above noted arrested accused person. In this regard, I beg to report that today i.e. on 13.12.2025 at 20:35 hrs, I received a secret information that one person is standing at Paribahan Nagar parking under Matigara PS jurisdiction with improvised fire arms and ammunition to deliver the same to his designated customer. Accordingly I diarized the matter at GD vide Matigara PS GDE No- 727, Dt- 13.12.2025 and informed the matter to I/C PS. As per your kind direction, at 20:40 hrs myself along with ASI Chandra Prakash Adhikari, ASI Bikash Roy, C/523 Sanjit Kundu, C/219 Sanatan Chitrakar all are of Matigara PS, SPC left for Paribahan Nagar parking under Matigara PS with investigation kit to work out the information in hand by Govt. vehicle. This refers to Matigara PS GDE No- 728, Dt- 13.12.2025. We reached at the spot i.e. at Paribahan Nagar parking at about 20:45 hrs and as shown by the source I was able to apprehend the suspected person at a abandoned shed at Paribahan Nagar parking. As per source information, that he was possessed fire arm. On being asked he disclosed his identity as noted above and admitted his guilt that he is in possession of fire arm. Accordingly I searched the above noted suspected person and found 1] One (01) improvised small fire arms having wooden butt measuring 08 (eight) inch approx in length from barrel to butt with one trigger, striking hammer, striking pin and one magazine in working condition and 2] Two (02) round of live ammunition inscribed "KF" "7.65" on its base from the back side pocket of the detained person. He exclusively possessed improvised fire arms and live ammunition illegally. On demand he failed to produce any document in support of the said improvised fire arms and live ammunition which has been found from his possession. On further interrogation he stated that he is coming from Panitanki and waited for his customer to deliver the same to his designated customer for his wrongful gain. Thus when his involvement in carrying and possessing illegal fire arms and live ammunition was established, I seized that 01 (One) Improvised small fire arms having wooden butt measuring 08 (eight) inch approx in length from barrel to butt with one trigger, striking hammer, striking pin and one magazine in working condition and two (02) round of live ammunition inscribed "KF" "7.65" on its base under proper seizure list duly signed by him as well as by available witnesses. Also labeled the seized articles. Accordingly, I, arrested the apprehended accused persons after issuing memo of arrest informing him about the ground of arrest. The whole processes of search, seizure, label and arrest was made in between 20:57 hrs to 21:15 hrs on 13.12.2025. The whole process of seizure was made under videography through WB E-Sakshya App.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the accused person namely Tengey Tamang (24 yrs approx), S/O- Lt. Phurba Temba Tamang of Sonada Ratomatey, PO- Sonada, PS- Jorbunglow, Dist- Darjeeling (not verified) is desperate and dangerous in nature, as he was carrying the said fire arms for sell purpose.

As he has willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Tengey Tamang (24 yrs approx), S/O- Lt. Phurba Temba Tamang of Sonada Ratomatey, PO- Sonada, PS- Jorbunglow, Dist- Darjeeling (not verified) under appropriate section of law and arrange for its investigation.
