**Subject: Filing of FIR Against Puja Mahato for Circulating Hate Speech on Social Media  
Regarding the Babri Masjid Verdict**

Respected Sir,

I, M.d. Hasim Ali, Vice Secretary of the Ashique E Rasool Committee, Siliguri, hereby lodge this formal complaint against **Puja Mahato**, resident of **Tulsinagar, Matigara, Siliguri**, for intentionally circulating hate speech through her Instagram and Facebook account concerning the **Babri Masjid verdict**.

On the said social media platforms, Puja Mahato has deliberately uploaded a video on 25.11.2025 containing derogatory, provocative, and inflammatory statements aimed at hurting the religious sentiments of the Muslim community. The content of the video is not only disrespectful but appears to have been purposefully created and shared with malicious intent to incite communal disharmony and disturb public peace.

Given that the matter relates to a highly sensitive religious issue deeply rooted in the faith of the Muslim community, such deliberate attempts to spread hate and provoke communal tensions can have serious implications on public order and harmony. Her actions constitute a blatant misuse of social media and fall under punishable offences as per relevant provisions of the **Bharatiya Nyaya Sanhita (BNS)** and the **Information Technology Act, 2000**.

The said lady is accused of creating videos full of derogatory remarks against the Muslim community and through her Instagram and Facebook account these obnoxious videos are widely circulated. On a previous case where this lady made a video where she used derogatory words and obnoxious comments on the Holy Prophet of Islam **Prophet Muhammad (peace be upon him)** because of which multiple F.I.R's have been filled against this lady.

I am attaching the **links** to the offending **Instagram** and **Facebook** video along with screenshots and other relevant evidence for your kind perusal and necessary action.

I request you to register this FIR at the earliest and take strict action against the accused to prevent further spread of such hateful, provocative, and communal content.
