Sir,

In producing herewith the accused person namely Sunil Tamang @ Chepe (M-29) S/o Shankar Tamang of Milan More, Sisha Dangi, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure viz :- (i) One black and yellow colour Bi-cycle style as "Hero" Next, (ii) One black and white colour Bi-cycle style as "SPRANDOM", (iii) One black colour Bi-cycle style as "Hero", (iv) One blue colour Bi-cycle style as "AFRO", (v) One black and red colour Bi-cycle style as "SPIDER KROSS", (vi) One black and yellow colour Bi-cycle style as "Hero Next", (vii) One black and blue colour Bi-cycle style as "HERO COLD", (viii) One black and yellow colour Bi-cycle style as "STARBURG" 6X10, (ix) One black and grey colour Bi-cycle style as "HERO NEXT", (x) One black and red colour Bi-cycle style as "INFINITY".

I, ASI Biplab Kumar Das of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Sunil Tamang @ Chepe (M-29) S/o Shankar Tamang of Milan More, Sisha Dangi, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 12.12.2025 at 22.10 hrs I received reliable secret source information that one person named Sunil Tamang @ Chepe of Milan More have stolen huge numbers of bicycle from different area of Siliguri and kept the same hidden in an abandon place at Regulated Market under PS- Pradhan Nagar, Dist.- Darjeeling. Accordingly, I diarized the matter in PS General diary vide Pradhan Nagar PS GDE No 724 dated 12.12.2025 and informed the fact to you and as per your kind order and direction myself along with SI Bandhan Roy, ASI Bikash Roy and ASI Prabal Sarkar along with force all of Pradhan Nagar PS left for Regulated Market to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No 724 dated 12.12.25. At around 22.25 hrs we arrived at the Regulated Market of suspect Sunil Tamang @ Chepe and conducted raid but found absconding. Then, I contact with my source while he stated that the said Sunil Tamang @ Chepe was available at Fruit Market at Regulated Market under PS- Pradhan Nagar, Dist.- Darjeeling. Accordingly, myself along with above mentioned officers and force arrived at Regulated Market and being pointed by the source, I detained one person at Regulated Market. On interrogation he disclosed his identity as noted above and on further interrogation he admitted that he stolen 10 (ten) numbers of Bi-cycle from different area of Siliguri during last 07/08 days and kept the same hidden in a abandon place at Regulated Market under PS- Pradhan Nagar, Dist.- Darjeeling. Leading to his confessional statement and being shown by him, I recovered the above noted 10 (ten) numbers of bicycle which were he kept hidden with a view to sale the same. On demand he failed to produce any documents in respect of above mentioned 10 (ten) numbers of Bi-cycle. There was sufficient reason to believe that the above noted 10 (ten) numbers of Bi-cycle recovered from the possession of accsued Sunil Tamang @ Chepe are stolen bicycle. Accordingly, I seized the above mentioned 10 (ten) numbers of bicycle under proper seizure list in presence of witnesses namely (i) Raja Sahani (M-26) S/o Chun Chun Sahani of Rajendra Nagar, Cooliepara, W/No. 1, P.S. Pradhan Nagar, Dist. Darjeeling and (ii) ASI Bikash Roy of Pradhan Nagar P.S./SPC under the coverage of video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling and through E-Sakhya Apps in between 23.25 hrs to 23.40 hrs as per norms of BNSS and subsequently, arrested the said detained person namely Sunil Tamang @ Chepe (M-29) S/o Shankar Tamang of Milan More, Sisha Dangi, PS- Pradhan Nagar, Dist. Darjeeling after observing all the formalities and brought to Pradhan Nagar PS for further investigation.

Under the above noted fact and circumstances, I therefore pray to you that a specific case under proper section of law may kindly be registered against accused namely Sunil Tamang @ Chepe (M-29) S/o Shankar Tamang of Milan More, Sisha Dangi, PS- Pradhan Nagar, Dist. Darjeeling and arrange for its investigation.
