Respected Sir,

I, Sushmita Mukherjee, daughter of Late Subodh Mukherjee, presently residing with my sister at 6B, block 4, Silver Oaks Residency, Mallaguri, P.S.- Pradhan Nagar, would like to inform you that I was married to one Shayan Ghosh, son of Subhash Ghosh, presently resident of C/O- Mrs. Pema Sherpa, Sherpa House, 1st Floor, Salbari, P.S. – Pradhan Nagar, District – Darjeeling on November, 2016 at Sevoke Kalibari, Sevoke and out of this wedlock we have a son namely, Shivin Ghosh who was born in the year 2021.

After the birth of my child, my husband subjected me to mental and physical cruelty, including abusive language, humiliation, and repeated demands for money.

That when my husband came to know that I have ancestral property and it is in the name of my sister namely, Mita Mukherjee Golay, he pressurized me to sell my ancestral property. Therefore, I asked my sister to sell the property and the said property was sold on August, 2023. After the said property was sold, my husband repeatedly insisted me to ask my share of consideration amount from my sister. But when I did not ask money from my sister, my husband started to harass me for money. In order to pressurize me for money, my husband deliberately left his job in Gangtok and shifted from Gangtok to Siliguri on March, 2024 and we started to reside in a rented house at Sherpa House, 1st Floor, Salbari, P.S. – Pradhan Nagar, District – Darjeeling. After this, my husband continuously harassed me for money. He used to ask me to bring money from my sister as he is having no job.

On 28.09.2025, when I refused to ask money from my sister, he brutally assaulted me, slapped me, and attempted to strangulate me. I narrowly escaped and called my sister for help. Though my husband later apologized in front of my sister and so I did not lodge any complaint against him as advised by my sister thinking about my child. I thought that my husband will change but his behaviour did not change. My husband has consistently shirked financial responsibilities, misused funds meant for our

child's education and ceremonies, and forced me to bear all household expenses and I used to take help of my sister.

That today on 13<sup>th</sup> December, 2025 my husband again asked me to bring money from my sister, but when I refused to do so, my husband became furious and he threatened me of dire consequences. He told me that unless the said money is handed over to him, they have no relation and he asked me to vacate my rented house with my child. That being fed up of daily tortures, I left my husband with my child and took shelter in my sister's house, leaving all my belongings in my rented house.

That his repeated acts harassment, assault, and cruelty have created an unsafe and unhealthy environment for me and my child.

Therefore, I request you to kindly register this FIR against Shayan Ghosh and take necessary legal action against him.
