After consultation of CCTV footage, I found on 28.11.25 at around 6 PM one unknown person entered into my residence by jumping the boundary wall and entered into my beddooms and at around 7 PM he left my residence from back side with a bag in his hand. I strongly suspect that the said unknown person stolen the following articles from my residence.


