Respected Sir,

I Sri Din Dayal Singh, Son of Shiv Mangal Singh, resident of Bholar Dabri, P.O. & P.S. Alipurduar, Dist. Alipurduar, (West Bengal), presently residing at Behind Frecia-II, Kalkut, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling (West Bengal) beg to state as follows :

That I am the absolute owner and in possession of two distinct plots of land (0.08 Acre + 0.05 Acre) measuring 0.13 Acre, out of which one plot of land measuring 0.08 Acre or 8 Decimals is situated within Mouza- Kalkut, J.L. No. 44, recorded in L.R. Khatian No. 6392 (old) and 6752 (New), comprised and included in R.S. Plot No. 217 corresponding to L.R. Plot No. 372, Police Station – Pradhan Nagar, Dist. Darjeeling (W.B.), the said property purchased by me vide registered Deed of Sale being Deed No. I- 1439 Dated 24/02/2025, registered in Book No. I, Volume No. 0403-2025, pages from 34766 to 34780, registered at the office of the A.D.S.R. Siliguri-II at Bagdogra, and I have been enjoying and possessing the said land since the date of such purchase, without any kind of objection, disturbance, or interruption whatsoever. Sir, I have already erected/constructed a 02'-00" Feet height concrete boundary wall alongwith numerous columns/pillars, fencing my entire land soon after my said purchase and I have also installed a tin shed structure on the said plot of land . The revenue record of the said land also stands in my land being L.R. Khatian No. 6752. I have also been paying the Panchayat Tax on the said land . I have also obtained electric connection on my said land being Consumer Id No. 4003731812 from the West Bengal State Electricity Distribution Company.

Sir, Since last few days some land Mafia's led by (1) Sarita Chowrasia, W/O Santalal Chowrasia, resident of Pokaijote, Mallaguri, (2) Sanjay Gupta, S/O R. Gupta, resident of North Mallaguri, alongwith with about 8-10 anti-social hoodlums and hooligans have been disturbing the peaceful possession of my property and threatening to murder me in order to Grab my said land and to capture my land forcefully . sir, I had lodged a written complaint in this regards on 03/12/2025 to your good office .
