(i) one white colour plastic sacks containing 02 (two) paper made cartoon, each cartoon containing 12 (twelve) bottles of Green Label Whiskey I,e total 24 bottles, each bottle containing 750 ml I,e, total 24 x 750 ml = 18 ltrs made in Sikkim (For sale in Sikkim only) marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1", (ii) one paper made cartoon containing 12 (twelve) bottles of Old Monk Deluxe Rum each bottle containing 750 ml i,e, total 12 x 750 ml = 09 ltrs. Marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and marked as Exhibit "B1" (iii) one paper made cartoon containing 48 (forty eight) bottles of Old Monk Deluxe Rum each bottle containing 180 ml, i,e, total 48 x 180 ml i,e total 8.640 Ltrs - Marked as Exhibit "C" out of which one bottle of the same taken as sample for examination and mared as Exhibit "C1" (iv) one blue colour Motor cycle (Scooter) Access-125 having Registration No WB/74/BU/4201 - Marked as Exhibit - D with its key.

**Subject: - F.I.R.**

Sir,

With due respect, I am producing herewith two accused persons namely (i) Raushan Kumar (35 yrs) S/O Late Umesh Chaudhury of Vill- Dhurgaon, PS+Dist. Madhepura, Bihar at present residing at Santoshi Nagar, PS- Siliguri, Dist.- Darjeeling and (ii) Raju Sah (35 yrs) S/O Umesh Sah of Vill Madhuapur, Mirchabari Chawk, PS- Jankinagar, Dist.- Purnia, Bihar at present residing at Santoshi Nagar, PS- Siliguri, Dist. Darjeeling under arrest under arrest and the following articles under proper seizure list viz :- (i) one white colour plastic sacks containing 02 (two) paper made cartoon, each cartoon containing 12 (twelve) bottles of Green Label Whiskey I,e total 24 bottles, each bottle containing 750 ml I,e, total 24 x 750 ml = 18 ltrs made in Sikkim (For sale in Sikkim only) marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1", (ii) one paper made cartoon containing 12 (twelve) bottles of Old Monk Deluxe Rum each bottle containing 750 ml i,e, total 12 x 750 ml = 09 ltrs. Marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and marked as Exhibit "B1" (iii) one paper made cartoon containing 48 (forty eight) bottles of Old Monk Deluxe Rum each bottle containing 180 ml, i,e, total 48 x 180 ml i,e total 8.640 Ltrs - Marked as Exhibit "C" out of which one bottle of the same taken as sample for examination and mared as Exhibit "C1" (iv) one blue colour Motor cycle (Scooter) Access-125 having Registration No WB/74/BU/4201 - Marked as Exhibit - D with its key.

I ASI Biplab Kr Das of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned two arrested accused persons namely (i) Raushan Kumar (35 yrs) S/O Late Umesh Chaudhury of Vill- Dhurgaon, PS+Dist. Madhepura, Bihar at present residing at Santoshi Nagar, PS- Siliguri, Dist.- Darjeeling and (ii) Raju Sah (35 yrs) S/O Umesh Sah of Vill Madhuapur, Mirchabari Chawk, PS- Jankinagar, Dist.- Purnia, Bihar at present residing at Santoshi Nagar, PS- Siliguri, Dist. Darjeeling to the effect that on 14.12.25 at 22.15 hrs I received source information that two persons would be coming to Siliguri Junction area from Santoshi Nagar area by a Motor Cycle with huge quantity of illicit liquor with a view to parcel the same to Bihar by Bihar bound bus. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No. 845 dated 14.12.2025 and informed the matter to you. As per your kind order and direction, I accompanied with SI Goutam Mallik, SI Rajiv Subba, SI Bandhan Roy, ASI Prabal Sarkar and force all of Pradhan Nagar PS left for Siliguri Junction by Govt vehicle with investigation kit to verify the veracity of the information. At around 22.30 hrs we arrived at Siliguri Junction in front of SJDA Building under PS- Pradhan Nagar, Dist. Darjeeling and contact with my source and being pointed by the source we noticed that two persons with a Scooter loaded with 3 cartoons are standing at in front of SJDA Building, Siliguri Junction. Accordingly, we detained them with the scooter loaded with three numbers of cartoons (two cartoon on leg passage and one cartoon on the seat). Thereafter, we disclosed our identities as Police personnel (as 4/5 police personnel of our team were in civil dress for our convenience) and informed them regarding the information in hand. On interrogation they disclosed their identity as noted above. On further interrogation they admitted their guilt and disclosed that the cartoon are loaded with Sikkim made liquor and they collect the same clandestinely from Sikkim with a view to parcel the same to Bihar and also disclosed that they are satndng there for Bihar bound vehicle. On searched the

above mentioned liquor was recovered from their joint possession which they kept concealed inside the cartoons. On demand they failed to produce any documents in respect liquor recovered from their possession. During local enquiry it could be revealed that both the detained persons are resident of Bihar and they are running such illegal business of liquor from their rented house at Santoshi Nagar without any documents since long for their wrongful gain. As the accused persons namely (i) Raushan Kumar (35 yrs) S/O Late Umesh Chaudhury of Vill- Dhurgaon, PS+Dist. Madhepura, Bihar at present residing at Santoshi Nagar, PS- Siliguri, Dist.- Darjeeling and (ii) Raju Sah (35 yrs) S/O Umesh Sah of Vill Madhuapur, Mirchabari Chawk, PS- Jankinagar, Dist.- Purnia, Bihar at present residing at Santoshi Nagar, PS- Siliguri, Dist. Darjeeling violated the norms of Bengal Excise Act, further I seized

the above noted articles under proper seizure list in presence of and subsequently arrested them under proper memo of arrest and observing all the formalites of arrest and also informed them regarding their ground of arrest and brought to the Pradhannagar PS to proceed further legal procedure. The whole process of search, seizure and labelling was made under the coverage of video graphs in between 22:55 hrs to 23:25 hrs at the spot as per norms of BNSS.

Therefore, I pray before your good self that a specific case may kindly be initiated against both the arrested accused persons namely (i) Raushan Kumar (35 yrs) S/O Late Umesh Chaudhury of Vill- Dhurgaon, PS+Dist. Madhepura, Bihar at present residing at Santoshi Nagar, PS- Siliguri, Dist.- Darjeeling and (ii) Raju Sah (35 yrs) S/O Umesh Sah of Vill Madhuapur, Mirchabari Chawk, PS- Jankinagar, Dist.- Purnia, Bihar at present residing at Santoshi Nagar, PS- Siliguri, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.


