In producing herewith three accused persons namely (1) Om Prakash Sah-18yrs s/o Lt Ram Dhani Sah of Nawada Mathiya PO Jalalpur bazar, PS Jalalpur Dist Saran Bihar (2) Anup Sah-28yrs s/o Lt Mungalal Sah of Juran Chapra PO Kishunpur PS Jalalpur Dist Saran Bihar and (3) Sachin Kumar-19yrs s/o Lt Suklal Kumar of Jalalpur near Jalalpur police station PS Jalalpur Dist Saran, Bihar along with the following seized articles as per proper seizure list:

1. 260 (Two sixty) bottles of Old Monk Deluxe Rum each bottle containing 180 ML which MRP Rs-66/ per bottle Manufactured by KANCHANJUNGA DISTILLERIES & LIQUORS Manpur, South Sikkim. (Total-46.800 liters) and marked as Exhibit-A one bottle taken as sample marked as Exhibit-A1
2. 24 (Twenty four) bottles of Old Monk Deluxe Rum each bottle containing 750 ML which MRP Rs-254/ per bottle Manufactured by KANCHANJUNGA DISTILLERIES & LIQUORS Manpur, South Sikkim. (Total-18 liters) and marked as Exhibit-B one bottle taken as sample marked as Exhibit-B1

I beg to report that I, ASI Dipak Karmakar s/o Dulal Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted persons to the effect that on 14.12.25 at 20.25 hrs received a source information from Samarnagar Boubazar under Bhaktinagar PS that three persons have gathered huge quantity of liquor in their possession at their rented house at Samarnagar Boubazar for transporting the same in Bihar for their wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-737 dated 14.12.25. As per your kind instruction myself along with ASI Khagen Barman, ASI Dhrubo Misra, C/374 Debraj Biswas and PS mobile van officer PSI Sahanur Rahaman (K-37) with force proceeded to the Samarnagar Boubazar to work out the information vide Bhaktinagar PS GDE No-738 dated 14.12.25.

At 20.50 hrs we reached at the spot and on the way I convinced the available public who were present at that time, following two persons came forward to accompany us for conducting search & Seizure if required, the details of individuals are (1) Subrata Chowdhury (Ph-8345865151) s/o Lt Nani Gopal Chowdhury of Samarnagar Boubazar near Jingel Bell school PS Bhaktinagar Dist Jalpaiguri (2) Dipak Mandal (Ph-9310086710) s/o Lt Rabindra Nath Mandal of Samarnagar boubazar near jingle bell school PS Bhaktinagar Dist Jalpaiguri. After reaching the spot found that all are manhandled by local public.

Sometimes after, being identified by the source our police party held raid and recovered the above noted articles from their joint possession in their rented house of Binod Kumar Prasad s/o Janak Prasad of Samarnagar Boubazar PS Bhaktinagar Dist Jalpaiguri at Samarnagar Boubazar. During local enquiry it came to learn that they are transporting the same to Bihar since one month for their wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from their possession after prepared proper seizure list and label, also arrested them after maintaining all formalities. Inform them about Ground of arrest in written. The whole process of search & seizure has been captured in audio & video records.. (The seizure was made in between 21.30 hrs to 22.25hrs)

After completed the all formalities the arrested persons are medically checked by on duty medical officer of Siliguri Dist hospital. Medical slips are enclosed herewith.

I therefore request you a specific case may kindly be started against the accused persons namely (1) Om Prakash Sah-18yrs s/o Lt Ram Dhani Sah of Nawada Mathiya PO Jalalpur bazar, PS Jalalpur Dist Saran Bihar (2) Anup Sah-28yrs s/o Lt Munglal Sah of Juran Chapra PO Kishunpur PS Jalalpur Dist Saran Bihar and (3) Sachin Kumar-19yrs s/o Lt Suklal Kumar of Jalalpur near Jalalpur police station PS Jalalpur Dist Saran, Bihar under proper section of law and arrange for investigation..
