With due respect, I SI Uttam Bagira presently attached with New Jalpaiguri Police Station, Siliguri Police Commissionerate under your kind control beg to state that on 04/12/2025 I was detailed as Night Kelvin 40 Mobile Van under NJP PS along with C/733 Alok Das and NVF/0068 Amit Roy vide NJP PS MCC No- 814/25 Dated 04/12/2025. During my mobile van duty at around 23.45 Hrs I received an information from the Control Room, Siliguri Police Commissionerate regarding one accident at Canal Road under NJP PS. Accordingly I had been to the spot and found that one unknown vehicle dashes the motorcycle bearing no-TC-134/25(Pulsar NS 125) due to rash and negligence driving and fled away from the spot. During this incident the rider of the motorcycle bearing Registration No-TC-134/25 (Pulsar NS 125) namely Manoj Roy (27 yrs./M) S/O- Adhir Roy of Khamakhaguri, Alipurduar received injuries in his person and with the help of local we immediately moved him to North Bengal Medical College & Hospital for his treatment.
