I, **Smt. Chandana Ghosh**, Daughter of Lt. Sukumar Ghosh, Hindu by Religion,
Indian by nationality, House wife by occupation, resident of Nabagram, Vidya Sagar
Sarani, P.O. Lake Town, Pin-734007, P.S. NJP, Dist- Jalpaiguri (WB) beg to state as
follows:

That in the month of August, 2020, one "**NARU DEY (SARKAR)**" who is a resident of
our Para Vidyasagar Sarani of Grocery Shop named-Laxmi Bhandar) introduced me
with one "**JUMKI MITRA**" W/O Shri Kuntal Mitra @ Subha Mitra, resident of Banaful
Sarani, Nabagram, Ward No. 33 of SMC, PO-Lake Town, Pin-734007, PS-NJP, Dist-
Jalpaiguri (WB).

That the said **JHUMKI MITRA**, had requested me to provide a loan of Rs. 500000 (Rs.
Five lacks only) for the personal need of her family (son's education) and she also
promised me that she will return the said amount with bank interest by the 7(seven)
months.

That she and her husband convinced me that her husband is a Government employee
and he will get a huge sum from his savings after 07 (Seven) months.

That on the instigation of "**NARU DEY (SARKAR)**" and after being convinced by her
husband and also after several requests made by **JHUMKI MITRA**, I on good faith and
trust, somehow managed a sum of **Rs. 4,20,000/- (Rs. Four Lacks and Twenty
Thousand only)** and I paid the sum to **JHUMKII MITRA** in presence of her husband
Kuntal Mitra @ Subha Mitra and "**NARU DEY (SARKARY)**" on 05/08/2020

That said Jhumki Mitra in assurance has provided two cheques bearing no.
018977 and 001221 of UNION BANK with the statements on stamp paper, copy
enclosed herewith.

After expiry of 7 (Seven) months I have been continuously asking for the refund
of my said sum of Rs. 4,20,000 (Rs- Four Lacks and Twenty Thousand only), but
Jhumki Mitra and her husband and **NARU DEY (SARKAR)** taking time after time and
harassing me.

That they have given me several dates for return of my money, but on every
date they were making new excuses.

Sir, lastly they have stopped communicating with me and I came to know that her husband **Kuntal Mitra @ Subha Mitra** is not a govt. employee and she personating as a public servant and at last I have realized that they have do the criminal breach of trust and cheated me.

After that I came to know that the said Lady **Jhumki Mitra** has taken money from the different people in that area with the conspiracy with her husband & Son and conduct a organized crime on same way and cheated people of that area.

I request you to take appropriate legal action in this regard against the culprits for recovery of my money.


