Sir,

With due respect I am producing herewith one (01) arrested accused person namely Arif Hossin (24/M) w/o Lt Amzad Hossin of Permanent Add- Vill- Lalbazar, PS- Sitalkuchi Dist- Coochbihar /Add Present- Bokravitta, Near Fire Brigade, PS- NJP, Dist.- Jalpaiguri under proper arrest memo and the following articles under seizure. The ground of arrest has duly been communicated with him.

- i) 12 (Twelve) bottles of 60 up Himalayan Gold, India made Liquor containing 600 ml each bottle

I SI Samik Paul presently attached with New Jalpaiguri Police Station under Siliguri Police Commissionerate under your kind control beg to state that today on 12/12/2025 during special raid duty received secret source information that above noted person selling huge quantity of liquor without any valid license for his illegal gain. Accordingly, I diarized the facts in General dairy vide PS GDE No: 620 dated 12/12/2025 and informed the fact to you. As per your kind direction and instruction myself along with ASI Manoj Majumder, C/453 Uttam Dey, VP/08 Laxman Roy, VP-13 Jamirul Islam left for More Bazar Area to work out the information in hand. We arrived at the More Bazar Area and being identified by the source we held raid and managed to apprehended in person. On search the above noted liquor recovered from his possession. On demand he failed to produce any documents/license in respect of store/sale the illicit liquor recovered from his possession. On being asked he disclosed his name and identity Arif Hossin (24/M) w/o Lt Amzad Hossin of Permanent Add- Vill- Lalbazar, PS- Sitalkuchi Dist- Coochbihar /Add Present- Bokravitta, Near Fire Brigade, PS- NJP, Dist.- Jalpaiguri and disclosed that he is selling such liquor since long for his illegal gain. Accordingly, I seized the above noted liquor from his possession under proper seizure list and arrested him under proper memo of arrest after observing all the formalities of arrest. The whole process of search and seizure as well as arrest was made in between 12.50 hrs to 13.35 hrs on 12.12.2025 (Total Seizure- 7.200 Liters)

Hence, I pray to you considering the offence a specific case may kindly be started against the arrested accused person namely Arif Hossin (24/M) w/o Lt Amzad Hossin of Permanent Add- Vill- Lalbazar, PS- Sitalkuchi Dist- Coochbihar /Add Present- Bokravitta, Near Fire Brigade, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation. Seized articles were handed over to the Makhana Officer with proper seizure list after maintaining all formalities.
