With due respect I beg to state that I Asif Ali SO- Maharam Sk of Natunjoy, PO- Jangipur, PS- Raghunathganj, Dist- Murshidabad presently posted at SAP 10th BN, Dabgramto the effect on 12.12.25 at 18.30 hrs myself along with colleague namely Abdur Rouf SO- Abdul Hoque of Dakshin Kanda, PS- Salar, Dist- Murshidabad had been to Noukhaghat More under NJP PS for performing Govt. Duty as per the detailment through bike. After reaching there I parked the bike and heading towards my duty post, suddenly one person restraint me to perform my Govt. duty and started abusing me with filthy language regarding parking issues. Later I came to know that the name and address of that person as Subha Das S/O Manoranjan Das of Deshbandhupara, W/NO- 30, PS- Siliguri, Dist.- Darjeeling. Then I along with my colleague, raised objections over the issue. Then the said Subhu Das along with one Rahul Banerjee S/O- Not Known of Shaktigarh, PS- NJP, Dist- Jalpaiguri got furious over us and started assaulted us with bike helmet, fists and bows after knowing that we were police personal and here for the Govt. Duty. During this incident, they also snatched my gold chain along with cash Rs. 3000/- from my possession. Over this incident we both received grievous injuries and got treated at Siliguri District Hospital. Further they also threatened us with dire consequences if they saw us in the area.

Therefore, I pray before you to kindly register the FIR against Subha Das S/O Manoranjan Das of Deshbandhupara, W/NO- 30, PS- Siliguri, Dist.- Darjeeling and Rahul Banerjee S/O- Not Known of Shaktigarh, PS- NJP, Dist- Jalpaiguri and arrange for its investigation as per the law.
