Sir,

In producing herewith One (01) accused person namely Md. Anowar (35 years/M) s/o Late Md. Eshad of Jhankar More, Gowala Patti, PS- Siliguri, Dist- Darjeeling under proper arrest memo and the following articles under seizure.

i) One (01) improvised fire arms measuring approx length 11" with 4" barrel, 4" body Iron made butt, 3" wooden made fitted with trigger, Hammer and firing pin concealed in Black and red colour handbag holding in right hand marked as Exhibit- "A"

ii) One live ammunition handmade length approx 3" marked as Exhibit- "B".

In this regard, I SI Samik Paul presently posted at New Jalpaiguri Police Station, Siliguri Police Commissionerate beg to report that today i.e. on 13.12.25 at 12.05 hrs, I received a specific secret information that one person namely Md. Anowar had been coming from Bihar side towards More Bazar Area under New Jalpaiguri PS for selling the firearms to designed customer. Accordingly, I diarized the information in General diary vide NJP PS GDE No 659 dated 13/12/2025 and informed the fact to you. As per your kind order and direction at 12.15 hrs myself along with SI Tanmoy Kundu, ASI Manoj Mujumder, C/453 Uttam Dey, VP 13 Jamirul Islam all of NJP PS left for NJP side under PS- NJP, with investigation kit to work out the information by Govt. vehicle to verify the veracity of the information. After being in the area i.e. More Bazar near Loknath Mandir under NJP PS and after waiting for a while as indicated by the source we noticed that one person was coming towards Loknath Mandir side. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we managed to apprehend him. On interrogation, he disclosed his identity as [redacted] above. As per our source information, he possessed 01 improvised small Fire arm and one (01) live ammunition. Hence, immediately we searched the person and recovered One (01) improvised fire arms measuring approx length 11" with 4" barrel, 4" body Iron made butt, 3" wooden made fitted with trigger, Hammer and firing pin concealed in Black and red colour handbag holding in right hand and one live handmade ammunition length approx 3' in presence of witnesses namely i) Dipak Sarkar (25) SO- Late Paresch Sarkar of Tawan Busty, PS- NJP, Dist- Jalpaiguri and ii) Bimal Das (36) SO- Krishna Das of Suryasen Colony, Block-E, PS- NJP, Dist- Jalpaiguri'. On demand he failed to produce any valid document in support of such possession of the said arms and ammunition. As the accused namely Md. Anowar violated the provision of Indian Arms Act.

Accordingly the arms and ammunitions were seized after preparing a seizure list duly signed by above noted witnesses and accused person. The seized arms and ammunition were properly labelled and arrested the above noted accused person under proper memo of arrest and the ground of arrest has duly been duly communicated with him.
