I, Bidhan Barman, Son of Rathaswar Barman, aged about 29, resident of Micheal Madhu Sudan Colony, P.O. Sahudangi Hat, P.S. New Jalpaiguri, Dist. – Jalpaiguri, do hereby like to inform you that yesterday on 13/12/2025 when a person namely Tapash Barman, Son of Sushil Chandra Barman, was coming from his work place through his two wheeler vehicle being No. WB 74BU 6874 at about between 2:00 p.m. to 3:00 p.m. he met with an accident near North Bengal Tea Park, Gora More main road, by a twelve wheeler truck. That the said offending vehicle was coming from Gora More towards NJP rly station. The incident took place due to rash and negligence driving by the driver of the said truck. Later on I came to know that the said person was standing at the extreme left of Gora mora Road and the offending vehicle was driven by one who seems to be negligent and driven like a drunken person. That subsequently the said person is admitted in the Thalamus Hospital, Fulbari Road, Dist. Jalpaiguri, and the said person is brutally injured and admitted in I.C.U..

That accident took place and the said arrived person is suffering due to the rash and negligent driving and act conducted by the driver of the said truck.

Under the above circumstances and fact it is prayed that pleased take the necessary legal action against the accused person by identifying and arresting him for the above offence.
