Respected Sir,

I, Smt. Mampi Deb Singha, W/o. Uttam Barman, D/o. Lt. Manoranjan Deb Singha, Currently Residing at Dabgram ,Nawapara, P.O. Sahudangi Hat, P.S. N.J.P. Dist-Jalpaiguri , Pin- 735135, would like to state that one love marriage was solemnized between me and my husband namely **Uttam Barman, (Ph. No. 6294092776)** in the year 2015 and thereafter lived as husband and wife at the matrimonial house of my husband at Uttar Parokata, Alipurduar- II, P.O. Uttar Parokata, Dist- Alipurduar, Pin-736202 and out of the said wedlock one female child was born namely **Rakhi Barman, aged 8 yrs. (Date of Birth 10.02.2017)**

That after a year of the said marriage the behaviour of my husband and In-laws changed against me. That my above named husband started love affair with some other person/ lady and he used to talk to her over phone calls till late night and when I opposed him to do such shameful act he used to come home at late night in a drunken condition and used to abuse me in a filthy language and used to assault me with fist and blows and mentally pressured me to die.

That my In-laws namely **1. Biren Barman (Father In-Law), 2. Sumitra Barman (Mother In-Law) and 3. Lipi Barman (Sister In-law)** used to torture me and when I was pregnant at that time they, along with my husband tried many times to kill my baby by physically assaulting me and also mentally torturing me so that I cannot sleep and also my husband many times kicked in my stomach so that by baby could die inside my womb as because he had love affair with a women namely **Rakhi Das, R/o. Batibari, Alipurduar** (as per my knowledge) and wanted to marry her.

As I am alone and my parents died and I did not have any one to support me, taking advantage of such my In- Laws mentioned above started to taunt me and treated me like slave and started more mental torture on me. They along with my husband physically torture me and they used to not provide me with sufficient food for me and my minor daughter also they used to make me work like slave whole day.

That after the aforesaid incident they again began more inhuman torture against me and my minor daughter by locking the door of my room whole day and not allowing me to go outside my room and during the night my husband physically assaulted me even tried to kill me by tying "gamcha" around my neck.

That in the year 2023, my husband along with my above mentioned In-Laws made a conspiracy and started to assault me with fist and blows and my In-laws pulled my hair and dragged me outside the house and also thrown my minor children and also stated that I have no place in their house and if I dare to come inside the house then they will kill me and my minor daughter and thereafter finding no other way I somehow went to my parents place for shelter.

That it is pertinent to mentioned here that my husband have married to another women (name mentioned above) and they are living together. That I am now spending my days in a very harsh condition with no one to support me as my parents died and when I call my husband for some help for our minor child over phone, he ignores the same and states that " why don't you both die instead of living". Even my In- Laws are stating the same thing. That now I am spending my days all alone with my minor daughter and managing all our financial problems and its becoming very hard to survive all alone.

Therefore finding no other alternative way I have come before you to lodge this written complaint **against the 1. Uttam Barman, 2. Biren Barman (Father In-Law), 3. Sumitra Barman (Mother In-Law) and 4. Lipi Barman (Sister In-law)** and take appropriate legal steps for the interest of justice.
