**Subject: FIR regarding robbery at knifepoint, assault, criminal intimidation, wrongful restraint, and vandalism of motorcycle**

Sir,

I, Aniket Dey Sarkar, son of Akhil Dey Sarkar, resident of Siliguri, 1 No. Dabgram, Ward No. 23, District-Darjeeling, West Bengal, do hereby lodge this First Information Report for your kind consideration and necessary legal action.

That today at about 8:00 PM, while I was proceeding on my motorcycle through the road adjacent to Binay More Bazar, within the jurisdiction of NJP Police Station, some anti-social elements who were in an inebriated condition deliberately attempted to obstruct my way and cause an accident. Thereafter, they forcibly stopped my motorcycle, wrongfully restrained me, and started abusing me in filthy and obscene language.

Suddenly, one of the accused persons, who was armed with a sharp knife, caught hold of my shirt collar, and when I protested, he removed the metal bangle (kara) from his hand and struck me forcefully on my chest, tore my shirt, and pressed my neck with his hands, thereby endangering my life. The accused also criminally intimidated me by threatening that “তোকে এই রাস্তায় এরপর দেখলে খুন করে এই নদীর পাশে ফেলে দেবো” (If I see you on this road again, I will kill you and throw your body near the river). Thereafter, by showing the knife and using criminal force, the accused robbed me of cash amounting to approximately ₹7,800/- (Rupees Seven Thousand Eight Hundred only) and also forcibly took away my silver kara (bangle) weighing approximately 8 vori. The accused further attempted to snatch my motorcycle keys and also vandalised my motorcycle by kicking it repeatedly and breaking the rear light, causing damage to my vehicle.

As per the local people present at the spot, the main accused is popularly known as "Vata", who was actively involved in committing the above offences. The accused was using a motorcycle bearing registration number WB74BB9741, which was present at the place of occurrence. I am in possession of photographs of the accused, which I am ready and willing to produce for proper identification and investigation. The above acts constitute serious cognizable offences including robbery with a deadly weapon, assault, criminal intimidation with threat to life, wrongful restraint, and mischief causing damage to property, causing me physical injury, mental trauma, and grave fear for my life.

I therefore request you to kindly register this complaint as an FIR, take immediate and appropriate legal action against the accused person(s), recover my robbed cash and silver kara, seize the offending motorcycle and knife, and also provide me necessary police protection, as I reasonably apprehend further danger to my life from the said accused.

I am ready and willing to cooperate fully with the investigation and to provide any further information or documents as may be required.
