Sir,

I, Smt. Soma Adhikari, wife of Sri Manoj Adhikari, aged about 27 years, resident of Block - E, Suryasen Colony, Ward No. 34, P.S. - NJP, District - Jalpaiguri, do hereby state the following on my own behalf and on behalf of my minor daughter aged 13 years, stating the facts herein below:

1. That I am the lawful mother and natural guardian of my minor daughter, namely Riya Adhikari, aged about 13 years.
2. That one Sri Deep Adhikari, son of Kamal Adhikari, resident of Block - E, Suryasen Colony, Ward No. 34, P.S. - NJP, District - Jalpaiguri (hereinafter referred to as the accused), is our neighbor and for the last few years, the accused has been continuously harassing me by passing dirty and defamatory comments and making indecent remarks about my character.
3. That since the last 6 (six) months, he also started following my minor daughter, who is only 13 years old. He would stop her and say bad and filthy things about me, her own mother. He tried to poison her mind by repeatedly telling her shameful and disturbing things which a child of her age cannot understand or handle which led to severe mental trauma, fear, humiliation and psychological pressure upon the minor child.
4. That due to such continuous harassment and mental torture, my minor daughter became extremely disturbed, withdrawn and emotionally broken, which ultimately led to a tragic incident.
5. That on 13.12.2025, unable to bear the mental pressure and trauma created by the continuous acts of the accused, my minor daughter attempted to commit suicide by consuming all the medicines available at home at once.
6. That immediately thereafter, she was rushed and admitted to North Bengal Medical College & Hospital, where she is underwent emergency treatment. Seeing my child fighting for her life is the most painful experience a parent can ever go through.

7. That on the very next day i.e. on 14.12.2025, the accused came inquiring about my minor daughter and when my husband came across the accused he confronted that his daughter is not a concern of the accused after which the accused started pushing my husband which led to a heated argument between my husband and the accused, during which the accused physically attacked me.
8. That in order to protect me from injury, my husband countered the attack, during which the accused sustained a head injury.
9. That at around 7 p.m., the family members of the accused namely Kamal Adhikari, Amal Adhikari, Shaan Adhikari and Gado Adhikari along with other family members came together and forcibly entered our house. I was inside my room from where they dragged me by my hair, they touched me inappropriately and attempted to strangle me and also abused me in filthy language.
10. That when my husband tried to intervene and protect me, one of the accused persons hit him on the back with a pipe, causing injuries and leaving both of us severely traumatized.
11. That they threw household articles all over the house, causing damage to our property and threatened us saying that our minor daughter was saved but they shall not spare our lives and we could not do anything about it as the uncle of the accused is a personnel working in Police Department.
12. That due to the entire acts of the accused and his family members, my entire family, especially my minor daughter, is terrified and emotionally shattered. We fear further harm from the accused and his family.

I am a helpless mother seeking justice for my child and respectfully request you to kindly register this complaint, take strict legal action against the accused persons and his family members, and provide us protection so that we may live safely and without fear.
