I, SMT MADHURI PAUL (SAHA), Wife of Sri Bappa Saha, Daughter of Sri Ram Mangal Saha, Presently residing at- C/o Sandhya Sutradhar, Lala Lajpat Roy Road, Ashrampara, P.O. and P.S- Siliguri, District- Darjeeling, Pin-734001, do hereby lodge this complaint against my husband to the effect that on 12/12/2025 at around 10:30P.M., my husband furiously entered my rented house where I am presently residing with my minor son and my mother. My husband started to abuse me with filthy words by holding one paper sent from Siliguri Court asking with rage why I filed case before the court for recovery of my maintenance amount vide Misc Execution Case No- 72/2025 (Arising out of Misc Case No-77/2023). To such loud voice I asked my husband not to shout as I reside in a rental house. Furiously my husband picked a coconut rope lying in veranda and caught holds my neck with an intention to kill me. Upon hearing my and mother's scream with fear, my landlord namely Smt Sandhya Sutradhar along with other tenants came to my rescue and upon seeing the gathering my husband threatened me to not pay a single amount of maintenance to me and my minor son and fled away. Later my mother and my landlord took me to Siliguri District Hospital and got me treated and hence I could not lodge the complaint immediately.

I had lodge one Domestic Violence Case against my husband before the **Ld. Judicial Magistrate 2nd Court, Siliguri** vide **Misc. Case No.-77/2023** wherein the Ld. Court was pleased to pass an order dated **07.06.2024**, the excerpts of which are as follows: "**the respondent no. 1 is directed to make payment of Rs. 3,500/- (Rs. 2,500/- for the petitioner + Rs. 1,000/- for her son) to the petitioner till disposal of this case as monetary relief by the 10th day of every succeeding English month, from the date of filing of this case i.e. from 18.05.2023.**

The arrear amount accrued for the period 18.05.2023 to 06.06.2024 is to be paid by the respondent no.1 within six months from the dated of this order.

The I/C Siliguri P.S. is hereby directed to provide all necessary legal assistance to the petitioner so that the order passed herein is implemented by the respondents."

Upon not receiving a single amount of maintenance amount from my husband I had lodged one Misc. Execution Case before Judicial Magistrate 2nd Court Siliguri for recovery of the due maintenance amount. Immediately after receiving the paper from the court my husband came to my rented house with the intention to kill me.

Kindly take immediate necessary legal action against the danger act cause upon me by my husband and please treat this as most urgent and do the need full.
