Sub: Written Complain

Respected Sir,

I Sri Subrata Ghosh, son of Late Sudhir Ch. Ghosh, resident of Rashbihari Sarani, Khelaghar More, Hakimpara, Post Office and Police Station Siliguri, Dist- Darjeeling, PIN- 734001, do bring to your notice about the criminal conduct of Sukumar Ghosh, Sri Gaurav Ghosh of Hakimpara, Siliguri.

I am one of the partner of the partnership firm under the name and style Subrata Ghosh and Company having its registered office at 12 B.B.D Bag, 1st Floor, Hemanta Bhawan, Kolkata- 700001. I through the said partnership firm have purchased a Generating set, SDS - SDSILMP on 28/12/2018 under a proper tax invoice from M/S Uttam Electricals. The said generating set is valued at Rs- 7,00,000/- (Rupees Seven lakh) only. That after purchasing, the said generating set was installed within the premises of Hotel Life Style situated at Airview More, Hill Cart Road, Siliguri. Immediate adjoining the hotel is Air View Hotel and Air View Lodge in which I am also a share holder. The said hotel is at present run by Sri Sukumar Ghosh S/O Late Sudhir Ch. Ghosh , Smt. Manju Ghosh, wife of Sri Sukumar Ghosh, Sri Gaurav Ghosh S/O Sri Sukumar Ghosh along with two others partners of the said partnership firm.

That due to work I have to travel a lot, and recently I am having a health issue and am constantly out of town, considering the giving situation the persons namely Sri Sukumar Ghosh S/O Late Sudhir Ch. Ghosh , Smt. Manju Ghosh, wife of Sri Sukumar Ghosh, Sri Gaurav Ghosh S/O Sri Sukumar Ghosh and Tapash Ghosh, Manager, Airview Hotel And Lodge without any consent or permission from the real owner of the said generating set, has most illegally made connection for usage at Air View Hotel and Air View Lodge and is using the said generating set from the premises of Life Style Hotel. To add more trouble they have forcefully put a pad lock on the said generating set and the key of the said pad lock are kept by the said Tapash Ghosh, Sukumar Ghosh and Sri Gaurav Ghosh. That on various occasions the authorized persons of our partnership firm have tried to take back the keys of the pad lock, but in all the occasions the representatives of our partnership firm are threaten with dire consequences by Tapash Ghosh, Sukumar Ghosh and Sri Gaurav Ghosh. I have personally requested them to stop using the generator and provide me with the keys but they have refused to do so and have openly asserted that they are influential people and that no body can stop them from using the generator.

It is to state that Tapash Ghosh, Sukumar Ghosh and Sri Gaurav Ghosh had thereafter assured me to pay an amount of Rs. 8,00,000/- for the price and usage of the generator within November 2025. I on trust that my hard earned money will be returned allowed them to use the generator, but in spite of the time assured they failed and refused to give the amount back as promised. I on 3.12.2025 went to the place and asked the money as promised but Tapash Ghosh, under the instruction of Sukumar Ghosh and Sri Gaurav Ghosh refused to give any amount as promised and threatened me to leave the place and expressed that they are adamant to do whatever required to do if I stop them from using the generator set and will do whatever they like. Fearing for my life I left the place.

That the said Sri Sukumar Ghosh S/O Late Sudhir Ch. Ghosh, Smt. Manju Ghosh, wife of Sri Sukumar Ghosh, Sri Gaurav Ghosh S/O Sri Sukumar Ghosh, Tapash Ghosh, are using the said generator set for running the hotel and lodge ~~including the restaurant~~ which is completely illegal and thus are committing an offence of theft on a daily basis by taking electricity from our generator set without the knowledge of the original owner. They I being the owner am not allowed to use the set and the same has been kept under lock and key which are in their possession. Tapash Ghosh, Sukumar Ghosh and Sri Gaurav Ghosh jointly have perpetrated fraud upon me and have committed criminal breach of trust.

I bring to your notice, that Sri Sukumar Ghosh S/O Late Sudhir Ch. Ghosh, Smt. Manju Ghosh, wife of Sri Sukumar Ghosh, Sri Gaurav Ghosh S/O Sri Sukumar Ghosh, Tapash Ghosh, Manager, Airview Hotel and Lodge have stolen my property and have dishonestly and with fraudulent intent caused wrongful gain and have deprived me of my property.

Therefore, it is requested that your esteemed office to kindly take the necessary legal action against Sri Sukumar Ghosh S/O Late Sudhir Ch. Ghosh, Sri Gaurav Ghosh S/O Sri Sukumar Ghosh, Tapash Ghosh, Manager, Airview Hotel and Lodge and book them under the relevant provision of law and punish them for their misdeeds.
