Sub: F.I.R. against Ram Chandra Sharma, S/o- Late Jiwan Ram Sharma, proprietor of Arena Multi Media Computer Centre, Ashutosh Mukherjee Road, College Para, PS- Sliguri, Dist- Darjeeling for theft of electricity u/s 135(1)(a) of the Electricity Act 2003.

Sir,

I, Sri Tapas Bishui, Divisional Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Ram Chandra Sharma, S/o- Late Jiwan Ram Sharma, proprietor of Arena Multi Media Computer Centre, Ashutosh Mukherjee Road, College Para, PS- Sliguri, Dist- Darjeeling for having committed offence as stated here under.

On 13.12.2025 at about 04:30 P.M. acting on a source information I, along with 1) Biswajit Ghosh, Linesman, Hakimpara CCC and other supporting staff of Mobile van entered the commercial premises of Ram Chandra Sharma, S/o- Late Jiwan Ram Sharma and inspected service installation and found electricity being stolen by two single core LT Cable with change over cut-out arrangement, so that the meter records less than the actual consumption as and when required. It is to mention here that he is the current user of the electricity connection in the name of the landlord Smt. Sudheshna Bardhan, W/O Sri Amitabha Bardhan. The Consumer ID of the service connection is 412049769, Meter Sl. No. IPB257591, 5-60AMP., MAKE: Bentec India Ltd., 3200IMP/KWH. The existing load found around 2.5 Kilowatt at the time of inspection.

As theft of electricity is detected the service connection has been disconnected and one portion of incoming white 2.5 sq.mm. service wire and tapping cable (2 meter approx.) black colour is seized by preparing a formal seizure list duly signed by the representative of Ram Chandra Sharma, S/o- Late Jiwan Ram Sharma and witnesses. The copy of the seizure list handed over to the representative of Ram Chandra Sharma and his signature obtained as token of receipt.

As Ram Chandra Sharma, S/o- Late Jiwan Ram Sharma has committed offence u/s 135(1)(a) of the Electricity Act 2003 by doing theft of electricity in the manner as stated above you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.

Today, on 14/12/2025, I am submitting this report as yesterday was a holiday and staff were not available in the evening; therefore, the report is being submitted today.
