Respected Madam,

With due respect I the undersigned would like to inform you that I am legally married wife of Sri Rohit Gupta, S/o. Subhash Gupta, resident of Samar Nagar, Champasari, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and our marriage was solemnized on 15.01.2025 against the will of our family members as because our marriage was a love marriage and the parents of my husband were against our decision so both of us decided to marry at a Durga Temple situated at Devidanga, near Devidanga Auto Stand according to Hindu Rites and Customs.

That after our marriage my husband brought me at my matrimonial house situated at Samar Nagar, Champasari, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and we were stay there as husband and wife in the joint mess. That soon after the elapse of few days my mother-in-law namely Sangeeta Gupta, father-in-law namely Subhash Gupta, Sisters-in-law Smt. Sona Gupta and Smt. Khushbu Gupta have started to abuse me with filthy languages and neglected my well being by not providing me proper food, clothing and shelter, the notion behind such an inhuman act against me was solely because of the fact that our marriage was a love marriage and my in-laws were not in a position to accept me as their son lawfully wedded Daughter- In -Law, as because their son is a business man and if his marriage would have been solemnized anywhere else then they would have got handsome dowry and daughter-in-law of their choice. It is pertinent to mention that when I stated all this incident to my husband and the mental trauma I go through on everyday basis from my in-laws it came to my utter surprise that my husband was sailing in the same boat as if all this tortures were plotted by my husband itself and he is the sailor of this ship. My husband at regular times used to taunt me to bring cash and gold ornaments as dowry from my mother as because my father is no more in this world.

That my husband at the end of January 2025 became very abusive and slap me on the pretext of alcohol and drove me out of the said room and told me to bring a sum of Rs. 10,00,000/- (Rupees Ten Lakh) only for his business purpose to purchase cloths from different State and also to bring the gold ornaments of her mother so that he can sale those and obtain cash and make it a valuable assets for his business.

without any reason and when I confronted as to why such abuse he told me that he is in an urgent need of money to clear his debt of a sum of Rs. 5,00,000/- (Rupees Five Lakh) only and when I said I have no money my husband had thrown me out from the rented house and told me to come back only when I bring dowry from my mother. It is pertinent to mention that all these acts and activities of my husband were solely on the basis of the instigation made by my matrimonial house i.e., by my mother-in-law, Father-in-law and sister-in-laws and the act of my husband to beat me and demand dowry from me was solely of the influence of my husband's mother and sister-in-laws. That my mother-in-law, father-in-law and sister-in-laws also instigated my husband in such a way that to abuse me in a way that I run away from my husband's life or I commit suicide.

That after the said incident I went to parental home and I asked my mother for five lakhs but after seeing my condition and marks of finger on my face my mother started to hue and cry and handed over a sum of Rs. 50,000/- (Rupees Fifty Thousand) only from her locker stating that "this is all I have which I had saved for your marriage all these years" and apart from that my mother is left with no money. That in the month of 5th day of October, 2025 I went to my rented house and I handed over the said money of Rs. 50,000/- (Rupees Fifty Thousand) only to my husband and after having the money in his hand he was happy but remained silent for few days as because there was wedding of my sister in the month of November, 2025.

That on 27.11.2025 I along with my husband went to my parental house for my sister's wedding and her wedding was solemnized on 29.11.2025 and everything was fine between me and my husband. That on 01.12.2025 we came back to our rented house, that on 04.12.2025 at around 06:30 p.m. my husband left for his parental house by stating that my mother-in-law wants to know how was the wedding of my sister and he will stay there for two days and he will come back on 06.12.2025 at night but he did not come back and when I called him numerous times he said he is busy and will call him back.

I took my friend to Siliguri District Hospital for my treatment due to extreme pain and when the doctor examine me the doctor told it's a police case as there is lot of blood clotting and slap mark on my face in the left chick and there is red mark in my right eye and immediate tests are required.

Therefore in view of the above I request you to kindly take strict legal action against the aforesaid named persons and to book them under the stringent provisions of law and also there is a immense life threat to me as because my husband is not at a conscious state of mind and wants to kill me by any means.
