I, the undersigned, hereby lodge this complaint with the following facts:

On 15/12/25 (date) at about 11:45AM (time), while I was on duty at Samridhi Neuro & ENT Multispeciality Hospital, a dispute arose with the patient party regarding non-payment of the hospital bill.

During the course of the argument, one male member of the patient party caught hold of my hand and pushed me forcefully, causing me mental trauma, fear, and humiliation at my workplace. The act was intentional and created a threatening environment within the hospital premises.

Such behavior towards a female hospital staff during official duty is unlawful and punishable under the law. I felt unsafe and intimidated due to this incident.

I kindly request you to register an FIR against the concerned person(s) and take appropriate legal action as per law. I am ready to cooperate fully in the investigation and provide further details if required.

Kindly do the needful at the earliest.
