I, Ruby Khatun, the above noted complainant beg to inform you that my marriage was solemnized with Md. Rahman (25) S/O Lt. Yusuf Saha of Tyokhraj Colony under Islamic law & customs, nearly 06 (six) years back, but since after my marriage, my above noted in-laws, started subjecting me for physical & mental cruelty for demand of dowry.

My husband always supported me but even after the death of my son, they did not stopped their atrocities on me.

That on dt. 17/12/2025 at about 11:00 pm, when I was at my matrimonial house at Tyokhraj Colony, at that time my above noted in-laws, demanded dowry from my mother namely, Diljan Khatun (43) w/o Late Md. Bahad of G/O Nander Chak, Tyokhraj Colony, Near Madrasa, Ward No 4, P.S-Siliguri, and when she denied they picked up wooden plank (Botam) & attacked on me and also beaten me brutally with fist & blunt end of received severe injury on my person and shifted to Siliguri Distt. Hospital by my said husband.

The above noted alleged persons are of very despute & dangerous in nature & they have threatened me for due consequence if me or my said mother will not fulfill their demand of dowry.

So, please take necessary action against them.
