
Respected Sir,

I Jhariya Roy, aged about 75 years, Son of Late Benani Roy, Resident of Adarsh Nagar Colony, P.S. Siliguri, Dist.: Darjeeling, begs to state as follows:

1. That I had filed an F.I.R. being NJP P.S. Case no. 699/20205 dated 10/10/2025, Under Section- 329(4)/305(a)/324(4)/3(5) of BNS, stating about the theft, trespass and mischievous acts of 20 to 30 miscreants who had entered my tin shaded pucca house on three adjacent lands at Jotymoy Colony, Nich Para, Ward No. 32, P.S. NJP, Dist.: Jalpaiguri, where my three sons were staying with their families before the house was lock & key by the IO of the NJP P.S. Case No. 125/2025.
2. That after the initiation of case against my sons and daughter in laws the houses were kept under lock and key by the IO of the case being No. NJP PS CASE NO 125/2025, it is seen that since long 20 to 30 miscreants have been coming to my house and have broken open the lock and key and have taken away all of the household stuffs and huge cash and jewellery.
3. That today again I received an information that the miscreants had again visited my 3 houses and the entire houses has been utterly ravaged, with the brick walls demolished and the gates of every room forcibly removed and taken away. The iron main gate has been taken away, leaving the premises exposed and vulnerable. Even the tin-shed structure has been dismantled and carried off, resulting in the complete devastation of the property and rendering the dwelling uninhabitable. I therefore request you to kindly take necessary legal action against the aforesaid culprits for the ends of justice.
