Jalpaiguri (2) Subrato Sarkar (37 yrs) S/o Shankar Sarkar (37 yrs) of Netaji Nagar, Near Masjid, W/No- 42, PS- Bhakti Nagar, Dist- Jalpaiguri (3) Md. Ismail (27 yrs) S/o Lt. Md. Faijiruddin of Amal Jhari, Near Masjid, PS- Islampur, Dist. Uttar Dinajpur (4) Taposh Das (24 yrs) S/o Lt. Shibu Das of Telipara, Near Primary School, Ashighar, PS- Bhakti Nagar, Dist- Jalpaiguri (5) Nirmal Roy @ Parimal (27 yrs) S/o Lt. I, ASI Dipak Karmakar S/o Lt. Dulal Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely 1) Bappi Mahato (27 yrs) S/o Lt. Ram Kishore Mahato of Khola Chand Fapri, Near Durga Mandir, PS- Bhakti Nagar, Dist. Jalpaiguri (2) Subrato Sarkar (37 yrs) S/o Shankar Sarkar (37 yrs) of Netaji Nagar, Near Masjid, W/No- 42, PS- Bhakti Nagar, Dist- Jalpaiguri (3) Md. Ismail (27 yrs) S/o Lt. Md. Faijiruddin of Amal Jhari, Near Masjid, PS- Islampur, Dist. Uttar Dinajpur (4) Taposh Das (24 yrs) S/o Lt. Shibu Das of Telipara, Near Primary School, Ashighar, PS- Bhakti Nagar, Dist- Jalpaiguri (5) Nirmal Roy @ Parimal (27 yrs) S/o Lt. Sudhir Roy of Telipara, Near Primary School, Ashighar, PS- Bhakti Nagar, Dist- Jalpaiguri (6) Mangal Raj Banshi @ Nepal (22 yrs) S/o Dilip Raj Banshi of Telipara, Near Primary School, Ashighar, PS- Bhakti Nagar, Dist- Jalpaiguri and 5/6 others to the effect that on 20/12/25 at 00:05 hrs received a specific source information that 11/12 miscreants have assembled at P.C Mittal Bus Stand under Bhakti Nagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 1010/25 dated 20/12/25 and as per order I along with ASI Khagen Barman, ASI Sadhan Kumar Roy, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for PC Mittal Bus stand under Bhakti Nagar PS, to work out the information in hand.

At about 00.20 hrs we arrived at PC Mittal Bus Stand under Bhakti Nagar PS, as indicated by the source we noticed that 11/12 persons assembled at PC Mittal Bus Stand under Bhakti Nagar PS, and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the Police party after somehow managed to apprehended above noted 06 (six) of them with deadly weapons from their possession but 5/6 persons managed to flee away from the spot taking the advantage of darkness and open place.

On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that they were present there along with others and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 20/12/25 in between 00.22 hrs and 00.50 hrs. The whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the below noted six (06) accused persons namely 1) Bappi Mahato (27 yrs) S/o Lt. Ram Kishore Mahato of Khola Chand Fapri, Near Durga Mandir, PS- Bhakti Nagar, Dist. Jalpaiguri (2) Subrato Sarkar (37 yrs) S/o Shankar Sarkar (37 yrs) of Netaji Nagar, Near Masjid, W/No- 42, PS- Bhakti Nagar, Dist- Jalpaiguri (3) Md. Ismail (27 yrs) S/o Lt. Md. Faijiruddin of Amal Jhari, Near Masjid, PS- Islampur, Dist. Uttar Dinajpur (4) Taposh Das (24 yrs) S/o Lt. Shibu Das of Telipara, Near Primary School, Ashighar, PS- Bhakti Nagar, Dist- Jalpaiguri (5) Nirmal Roy @ Parimal (27 yrs) S/o Lt.
