Respected Sir,

I, Raj Kumar Prasad, son of Sri Bhola Saw, of mandu Ramgarh ps mandu dist Ramgarh by profession I am engaged in the scrap business. I most respectfully submit this written complaint for your necessary legal action.

That one Sourabh Singh s/o Surendar Pratap Singh of Road No 02, Oberia Road, Pragati Nagar Hatiya Rachi Jharkhand, Pradip Sharma s/o Lt Ram Swarup Sharma, and Sagar Kumar Singh, entered into a verbal business arrangement with me and Binod Bhagat as partners for scrap-related transactions.

That based on their representations and assurances, I transferred and advanced various sums of money to different bank accounts of the above-named persons, On 13.12.2025 - Rs. 9,18,000/-, On 17.12.2025 (through SGST transaction) - Rs. 3,05,000/-, and an advance amount paid about two months prior - Rs. 5,00,000/- Thus, a total sum of Rs. 17,23,000/- (Rupees Seventeen Lakh Twenty-Three Thousand only) was paid by me to them.

That the above-named persons had informed me that the scrap material was being transported through a vehicle bearing registration number WB-37E-4770. However, on 21.12.2025 at about 12:00 hours, upon visiting Fulbari Parking, I noticed that a portion of the said scrap material was being loaded into another vehicle bearing registration number JH-05DX-1977, under the supervision and leadership of Pradip Sharma. I further observed that six number plate is present in the vehicle having registration no WB-37E-4770.

That the accused persons have dishonestly misused the scrap material, which was entrusted to them for business purposes, for their own wrongful gain.

That they have cheated me and dishonestly induced me to deliver money and property, knowing fully well that they had fraudulent intentions from the very beginning.

That I further came to know that the said scrap material was found stationed at Fulbari Parking under NJP Police Station, clearly showing their wrongful intention, common intention, and criminal conspiracy.

That the above acts of the accused persons disclose the commission of offences. Therefore, I most humbly pray that you be pleased to Register an FIR against the above-named accused persons, Take necessary legal action in accordance with relevant sections of law.
