I Sri.Sanjay Karmakar, resident of 87 J.C. Bose Road, P/O & P/S Siliguri as Manager of Hotel Sharda Restaurant cum Bar, Mallaguri, PO & PS. Pradhannagar would like to lodge a complaint against Seikh Mon of NJP, Siliguri, who posed as a staff of Naxalbari Electric Office and took Rs. 1,15,000/- on behalf of Naxalbari Electric Office and being fraud to us.

I put an application to install a transformer at our under construction residential hotel site at Rathkhola, Naxalbari. Subsequently Naxalbari Electric Office has done inspection several times at our site. Seikh Mon was along with the inspection team with official identity card on his neck. As there was need to shift two high tension electric poles to another place of that site Seikh mon assured us shifting of these poles and took Rs. 70,000/- on dated 19 November of 2024 and Rs. 45,000/- on dated 23 November as Quotation Charge of shifting of these poles from our registered office at Sharda Hotel bar cum restaurant.

Having no response in one year we went to the Naxalbari Electric Office and came to know that Seikh Mon is a casual staff of that deptt. We compelled to deposit the quotation money again by ourselves for shifting of these poles.


I therefore would like to request you to kindly make an enquiry of this matter and take necessary action towards recovery of our money from him which he had taken from us for this work.
