Sir,

I Puja Sah, W/O Binod Sah, R/O Shiv Nagar, Darjeeling More, P.O.&P.S:
Pradhan Nagar, dist: Darjeeling, Siliguri, West Bengal, Pin- 734003, I would
like to draw your kind attention to the following effect that on 22.11.25 I had
lodged a complaint against Manoj Singh S/O not known 2. Subod Thakur S/O
not known 3. Sangeeta Thakur W/O Subod Thakur (**Pradhan Nagar P.S Case
No. 776 of 2025**) and in this case the aforesaid accused persons are on interim
bail. That again on 17.12.25 at around 11.00 P.M at that time of night when I
was alone in my home with my 2 kids, which is situated at the abovementioned
address, without any rhyme and reason that aforesaid Subod Thakur and
Manoj Singh without my permission entered into my house by forceful manner
and threatened me by using filthy languages and told me that they will not
hesitate to kill me and my family members, at that time one of them i.e.
aforesaid subod thakur grabbed my dupatta by saying that I have to face dire
consequences if I will not withdrawn the police complaint that I have lodged
earlier against them with the **I.C. of Pradhan Nagar P.S on 22.11.25 vide
Pradhan Nagar P.S Case No. 766 of 25**, on protesting against their aggressive
behavior at that moment they all together by using the advantage of absence of
my husband they grabbed me tightly by holding my hands and one of them
tried to strangulate my neck and consequently threatened me that weather I
am ready to withdrawn the case that I have lodged against them or not. But I
was not in a position to take any further apart from shouting loudly with the
hope that someone will come and save me from their clutches, and thereafter
when my children started to cry and shout out loud, my neighbors came
hearing the noise and saved me from the clutches of the abovementioned
persons, and after sometime my husband also came home. When my husband

tried to clarify the things that why the abovenamed persons enter our house, they started to beat my husband too. **I have annexed the Medical documents of my husband with this FIR. My husband is a psychiatric patient and is undergoing Medical treatment from North Bengal Medical college and hospital Darjeeling (Siliguri, West Bengal, pin: 734012), this is also annexed with this complaint.**

That abovementioned person threatened me again and again by saying that they will kidnap my children and kill my husband. Being a helpless woman, I am currently living with great fear of death.

Some unintentional delay has happened in registering this FIR because of I am currently suffering from insomnia .Therefore being a helpless lady I am requesting you to take necessary legal action against the abovenamed persons as per procedure of law and look into the matter at the earliest.
