

**Sub: Complaint (F.I.R.)**

I, Chandana Roy Chowdhury, Wife of Bidhan Roy Chowdhury, presently residing of Chhotamohan Singh Jole, P.O. - New Rangia, P.S. - Matigara, District - Darjeeling; do hereby provide you with this complaint against the Hit and Run incident, along with the facts as follows:

1. That on 10-12-2025, at around 10:30 p.m., one To-To driver had called me from my said husband's mobile phone, and I was informed that my said husband (Bidhan Roy Chowdhury) was hit by one two-wheeler motorcycle/bike coming from the wrong-way at the exact location of the traffic crossing at Shivmandir-Medical More (Asian Highway); and my said husband (Bidhan Roy Chowdhury) was being taken to be admitted to the N.B.M.C&H.; further at once, I along with other family members rushed towards the said hospital.
2. That further, after shifting my said critically injured husband (Bidhan Roy Chowdhury) for proper treatment at Neolla Getwei Hospital, I along with my daughter visited the incident spot and it came to our knowledge that, on 10-12-2025, at around 10:00 p.m., while my said husband (Bidhan Roy Chowdhury) was walking towards our above mentioned residence, a recklessly driven two-wheeler motorcycle/bike, had hit my said husband (Bidhan Roy Chowdhury) and

ran away without helping my said husband (Bidhan Roy Chowdhury), at the exact location of the traffic crossing at Shivmandir-Medical More (Asian Highway).

3. That it also came to our knowledge that, Sukhen Barman, resident of Bidhanpally, was riding the said two-wheeler motor-cycle/bike. Further, the recorded owner of the said two-wheeler motor-cycle/bike, is Bikram Paul, resident of Shivmandir. On the same note, it has also come to our knowledge that, the said Sukhen Barman, does not have his driving license and is illegally riding the said bike with the full knowledge of the said Bikram Paul.
4. That I along with other family members also visited the houses of the above mentioned person(s), namely, Sukhen Barman, and Bikram Paul, to question about the said incident. But they refused to cooperate and also ignored our requests to assist and help us.
5. That my said critically injured husband (Bidhan Roy Chowdhury) haven't recovered from his injuries and is still admitted at the Neotia Getwel Hospital.

Therefore, I pray before your office to take an immediate action(s) against the said person(s), Sukhen Barman, and Bikram Paul; and look onto this matter for the ends of justice.

Consideration of Delay: That due to such above mentioned Hit and Run incident, my whole family and I were totally engaged with the treatment

and taking care of my said critically injured husband (Bidhan Roy Chowdhury). Further, due to such chaos, I was not able to file this said complaint at once. Therefore, I would like to pray for your kind consideration for the delay in filing this said complaint.
