I, **BIKI MAHATO**, son of Okil Mahato, residing at Santoshi Nagar, Near Vishnu Mandir, P.O. & P.S. Siliguri, District - Darjeeling, respectfully submit this written complaint for your kind consideration. On **11 December 2025**, at around **00:25 AM to 00:45 AM**, I was travelling towards Matigara on a scooty along with my younger brother, Shivam Mahato. When we reached near Darjeeling More, outside at the National Highway under the jurisdiction of Siliguri Police Commissionerate, an unknown four-wheeler vehicle, coming from the Commissionerate office direction at high speed, suddenly and without any warning, hit our scooty with great force. Due to the impact, both of us fell onto the road, and immediately thereafter, the said vehicle sped away from the spot, committing a clear hit-and-run offence. Owing to the suddenness of the incident and the late-night conditions, we were unable to note the registration number of the offending vehicle.

As a result of the collision, my younger brother sustained a severe fracture in his leg and was unable to move. I also suffered injuries on various parts of my body. With difficulty, I managed to take my brother to **Neotia Hospital** for immediate medical treatment. Thereafter, upon medical advice, he was shifted to **Maya Sanyal Clinic & Nursing Home**, where his surgical operation has been conducted today. The nature of his injuries and the need for surgery clearly establish that the accident occurred solely due to the rash, negligent and reckless driving of the unknown vehicle's driver, who fled the scene without providing any assistance or reporting the accident, thereby endangering our lives.

In view of the above facts, I humbly request you to kindly register an FIR under the appropriate provisions of law, including those applicable to rash and negligent driving and hit-and-run cases, and to initiate necessary steps to identify the offending vehicle and its driver through CCTV footage, highway surveillance and other investigative methods. I further request you to take strict legal action against the person(s) responsible for this incident. I am submitting the medical records, treatment papers, operation details and other relevant documents for your kind perusal.
