That thereafter I alongwith my friend Ashwathi Prasad Sarkar fell on floor bike. That angles I stood up and thereafter I asked Toto Driver dont you know to drive and listening this toto driver become furious and further said me take Rs. 500 and get lost. That when I said him I will file complain against you he directly hit me on my face. That my friend Pinki Sarkar came forward to save me but unfortunately she was physically assaulted by him gave her most filthy slaps. That by time said toto driver had called other toto driver and they deliberately and with Criminal Intent, ^{started} beating me mercilessly with sharp weapons, fist and blunt. That after said incident I was taken to hospital by some well wisher. That during the said incident my helmet was lost. That one of the person was taken in police custody namely: Bhawani Bormia while the other elopes
