In producing herewith one four wheeler vehicle loaded with two cattle in burnt condition along with seizure list.

On 19/12/25 I was detailed to perform mobile petrol duty along with force vide GDE no. 1034, Dt. 19.12.25 and MCC no. 2753/25 w.e.f. 22.00 hrs to 19.12.25 08.00 hrs on 20.12.25. On 20.12.2025 at about 03.30 hrs, during my said night patrolling van duty received an information from SPC control room that one vehicle has been caught fire on the road at Shibmandir medical more under Matigara PS, Dist Darjeeling. Accordingly I along with force had been at Shibmandir Medical more and found one Scorpio vehicle on the road turning near Mukta Nursing home. Myself along with force and with the help of Fire brigade personnel succeeded to control the fire. On physical verification I found the vehicle is Mahendra Scorpio and loaded with two cattle on the backside of the vehicle and both are fully burnt. I search nearby areas for the owner or driver of the vehicle but found none. I searched the Registration number and Engine number of the vehicle but due to ashes on the vehicle I could not fix the same.

On verification I could not found any documents in respect of the cattle or vehicle. Under the above circumstances there is a reasonable ground to believe that the cattle might be stolen one and transported at the odd of night on the vehicle in illegal manner. Hence I seized the above noted articles under proper seizure list. The seizure was made in between 05.35 hrs to 06.05 hrs with proper videography.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused owner/driver and others and arrange for its investigation.
