With due respect, I am producing herewith the 03 (Three) arrested accused persons namely (i) Bikash Oraon (26 years approx) S/o Lt. Budhuwa Oraon of Barodighi Malbazar P.O+PS- Malbazar Dist. Jalpaiguri, (ii) Ashok Gowala (30 yrs approx), S/o Lt. Kashi Gowala of Damdim Gooddhap Bagan, P.O+PS- Malbazar, Dist- Jalpaiguri (iii) Aswin Thapa (28yrs approx) S/o Amrit Thapa of Matigara Bazar, opposite lexicon motors, P.O+PS- Matigara, Dist- Darjeeling and the following articles under seizure :-

1. One iron made Die measuring approximately 02 feet from the possession of accused named Bikash Oraon.
2. One Torch light & one Plus from the possession of accused person named Ashok Gowala.
3. One Hacksaw from the possession of accused person named named Aswin Thapa.

I, ASI Chandra Prakash Adhikari of Matigara PS, Siliguri Police Commissionerate beg to state that on 20.12.2025 at 23.15 hrs, received a secret source information that a gang of miscreants were assembled at beside Simultala IT park phase III area under Matigara PS, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Simultala area. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI Dipak Kr. Chhetri and C/219 Sanatan Chitrakar, C/868 Sujal Roy, C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for Simultala IT park phase III area, PS- Matigara, Dist.- Darjeeling to work out the information in hand vide Matigara PS GDE No. 1108 Dated- 20.12.2025. At about 23.25 hrs we arrived beside at Simultala in front of IT park phase III area under Matigara PS. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled Simultala in front of IT park phase III and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 03 (Three) persons of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there for making preparation for committing dacoity in Simultala area. They also stated that others 07/09 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles from their possessions. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 03 (Three) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure was made in between on 20.12.2025 at 23.35 hrs to at 23.45 hrs. The whole process of search & seizure was made under video graphy.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely namely (i) Bikash Oraon (26 years approx) S/o Lt. Budhuwa Oraon of Barodighi Malbazar P.O+PS- Malbazar Dist. Jalpaiguri, (ii) Ashok Gowala (30 yrs approx), S/o Lt. Kashi Gowala of Damdim Gooddhap Bagan, P.O+PS- Malbazar, Dist- Jalpaiguri (iii) Aswin Thapa (28yrs approx) S/o Amrit Thapa of Matigara Bazar, opposite lexicon motors, P.O+PS- Matigara, Dist- Darjeeling and others and arrange for its investigation.
