Sir,

In producing herewith the 02 (two) arrested accused persons namely 1] Gouranga Adhikari (34 yrs) S/O Late Prahlad Adhikari, of New Rangia, Chaitanyapur, PS Matigara Dist Darjeeling 2] TotUn Roy (24 yrs) S/O kailash Roy of New Rangia PS Matigara Dist Darjeeling along with the following seized article under proper seizure list:

- 1) One Dumper bearing Reg No. WB 73 D 7192 fully loaded with riverbed materials.
- 2) One Dumper bearing Reg. No WB 73 H 1786 fully loaded with riverbed materials.

I S.I Prabir Roy of Matigara P.S. Siliguri Police Commissionerate, do hereby lodge this written complaint to the effect that on 22.12.2025 I was deputed to perform Mobile Van duty along with force since 14.00 hrs to 22.00hrs, vide C.C. No. 2790/25, Dated 22/12/2025 and GDE No. 1189, Dated 22/06/2025 in the said mobile van duty I received source information that Two Dumpers are coming from Tarabari Ghat towards Ninety nine(99) more under Matigara PS Dist Darjeeling fully loaded with river bed material which were procured clandestinely. Accordingly I informed the matter to I/C Matigra P.S over phone, he immediately directed me to work out the information in hand. Accordingly, I along with force rushed to said area and intercepted above mentioned two Dumpers at Ninety nine more fully loaded with river bed materials and apprehended above mentioned persons who were driving the said dumpers and detained them. On interrogation they disclosed their names and addresses as above and they could not able to produce any valid papers of the above noted seized articles, it is believed that they procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means from somewhere, for their wrongful gain and to deliver the same to their designated customer. I duly seized above noted dumpers fully loaded with river bed materials, after preparing proper Seizure List. I arrested the above noted 02 (two) accused persons and issued arrest memo to them accordingly, duly signed by the accused persons and I also communicated them the ground of their arrest. The whole process of search and seizure and were made in between 14.50 hrs to 15.10 hrs on 22/12/2025 under proper videography..

Under the above noted fact and circumstances you are requested to kindly start a specific case under proper section of law against arrested accused persons namely 1] Gouranga Adhikari (34 yrs) S/O Late Prahlad Adhikari, of New Rangia, Chaitanyapur, PS Matigara Dist Darjeeling 2] Totan Roy (24 yrs) S/O kailash Roy of New Rangia PS Matigara Dist Darjeeling and arrange for its investigation.
