Respected Sir,
I, Mrs. Eri Roy, wife of Lt. Mrinal Kanti Roy
Savi Anchal, Road 2A (Ram Krishna Sarani),
734003, Siliguri, West Bengal wish to report
an incident that occurred today on 20th
December, 2025 at about 3:50 PM at the
residence of Mr. Nripendra K. Sarkar, who is
related to me as my brother-in-law.
I, along with my daughter, my son,
and my daughter's boyfriend went there
only to speak with him regarding an
ongoing verbal and physical harassment
done up on my daughter. Initially, his family
members avoided any discussion. When Mr.
Nripendra Kumar Sarkar arrived later, he
became aggressive and threatening and
moved towards me as if to physically
assault me, sending danger, my son
intervented, and a scuffle occurred causing
a violent situation.

When I tried to calm down the situation and charge him again he deliberately hit me physically and also tore off my nighty publicly inside his residence itself, causing fear and disturbance. Also I and my whole family sensed that he was fully ~~drunk~~ drunk in that very situation.

Due to this incident, we feel unsafe and apprehend further harm from him. I request you to kindly record this complaint, make a GD/FIR entry, and take necessary steps to prevent any further disturbance or violence on me and my family.
