Such Mobile towers are essential for transmitting the receiving signals and considered as an urgent service, which our client is bound to render to the public at large.

On 26 Oct 25 during inspection of the Unmanned site situated at Siliguri Salbari ATC site Id. 561196, site address : Kalibari Road, Salbari, Champasari, Anchal, P.O – Sukna, P.S- Pradhan Nagar, Dist - Darjeeling under Pradhan Nagar Police Station was found that out of a total of approximately 180 mtrs of said tower power cable around 60 mtrs have been stolen and the remaining power cable have been damaged by unknow person. This incident has caused financial loss to our company and has disrupted our operational work.

Considering the incident, I would request you to lodge a GD/FIR and oblige.
